REMARKS

a. - The Prefect was appointed by AMG on 4/1/44 Vice Rosario SPECIALE, removed for inefficiency.

c. - MANNINO was appointed Ragioniere Capo - Ispettore (Grade VIII) in 1940. On 8/2/44, the then PC Capt. W.M. Harrison, made an Order appointing him Vice-Prefect Inspector (Grade VI) with effect from 1/2/44. The Prefect reported this appointment to the Ministry on 10/4/44 and recommended the Ministry to confirm it. In so doing he stated that the AMG appointment was made in recognition of MANNINO's services. MANNINO however still calls himself Ispettore dei Comuni (Grade VIII) because he has "jumped" a grade and fears bureaucratic intrigues if he openly assumes the higher rank. He is as Capo di Gabinetto, q.v. sub.

b. (5) The former Director of Religious Affairs was attached to the Court of Appeal at Catanzaro, where religious administration was the affair of the Ministry of Grace and Justice. Upon transfer of these functions to the Ministry of the Interior the Director became an official of the Catanzaro Prefecture. In Reggio functions as to religion are one of the Divisions supervised by a Councillor.
