COMMENT:

Interview by Director on Monday, 14 August 1944

He struck me as a typical civil servant with rather more force of personality than many other that I have met. Stated that he realized he had an extremely difficult task in Cosenza and that he shows a certain amount of apprehension in this connection. I am not prepared to make further comments, but I think that at this stage he should be judged by his work, rather than by his appearance.

REMARKS

- a. The Prefect has since (on April 22nd., 1944) been made Socialist Minister without Portfolio in the new Badoglio Government.
- c. The Vice-Prefect Vicario stated that the former Vice-Prefect Inspector was transferred to another ~~post~~ ^{post} (he could not remember where) and that a successor awaited. In the meantime, Rag. Pasquale Passavanti Ragoniere Capo, is exercising the Inspectors functions.
- d. (2) Dott. Emanuele Cottugno has been suspended by the Prefect Mancini on the ground of Fascism - Squadrista, Marcia su Roma and Sciarpa Littorio - . The Vice Prefect Vicario says he is 70 years old, was not an active Fascist and never did any harm to anyone.
- g. The former Questore, Comm. Francesco Buscemi, has been transferred to Palermo. Cav. Uff. Guglielmo Lauro, Commissario Capo con funzioni di Vice-Questore is acting in his place.

- a. The Prefect MANCINI said he reconstituted the G.P.A. in this form about 20 November 1943. Neither the Vice-Prefect Inspector or the Ragioniere Capo are members at present in this Province. Mancini usually provided himself. The G.P.A. met fortnightly at first but now the Prefect cancels the meeting if there is not enough business.
- c. The Capo di Gabinetto Dr. Alfredo BLASI is also a Prefectural Councillor IInd. Class.

- a. The Prefect MANCINI and the Provincial Legal Officer Capt. LITTLE (A) used the term "Preside" but the Vice-Prefect Vicario said that "Commissario Straordinario" was strictly correct as he had been appointed by the Prefect to replace a former Fascist Preside.
- c. The Prefect MANCINI stated he proposed to appoint 5 members to form the Deputazione Provinciale and that they would be selected 2 from the Cosenza District and one each from the Castrovillari, Paola and Rossano District. According to the Codified Law of 1915, this Province with a Population (estimated 1942) of 633 736 should have a Deputazione of 10 members.
