SUBJECT: Employment of women in the administration

TO : RC, Region IV

1. I refer to the Demi-official letter that Brigadier Dunlop wrote to me on this subject on 14th July under reference RA/337(R4)
2. I have consulted the Minister of the Interior about this. He states that no provision has been issued by the Italian Government forbidding the employment of women in public administration; and therefore any steps that may be taken by local authorities against the employment of women in public offices do not correspond to the directives of the Italian Government.
3. In his letter Brigadier Dunlop said that his Provincial Commissioner asked whether we should intervene. This is Military Government Territory and the Prefect Regent must take his instructions from you. It seems to me you are fully entitled to give directions reversing the action of the Prefect Regent in dismissing women - if you consider that, as a matter of policy, it ought not to be done - the more so as the practice of the Italian Government does not support the Prefect Regent's actions.
4. In view of the extreme shortage of personnel of all grades in the various public administrations, it does seem to me most inappropriate at the present time to dismiss women merely on the grounds of their sex.



Dear Spicer

I have a complaint from one of my Provincial Commissioners that his Prefetto Reggente is dismissing female employees as a matter of policy, and replacing them by men. My Commissioner asks whether we should intervene. I imagine that in Italy the employment of women in the Government Services has not progressed anything like the distance we have gone in Great Britain and the United States. Moreover, it does appear to me that this is a matter which should principally concern the Italian Government. I should, however, be very glad of your advice.
