Reference your letter AC/4/7/1/LG dated 30 January 1945, regarding the orders appointing Dr. Francesco ARIA as Prefect of Aquila Province.

1. Investigation discloses that Regional Order No. 4, which should have appointed Dr. ARIA as Prefect of Aquila, with effect from 5 July 1944, was never issued.

2. This was due to the fact that the Provincial Commissioner had immediately requested a replacement for Dr. ARIA. Colonel WHITELY, then the Regional Commissioner, delayed issuing the orders for the appointment owing to the unsatisfactory reports he had received in regard to Dr. ARIA. Colonel SPICER'S letter ACG/4/1/42/Int of 18 July 1944, rejecting the request for a substitute, reached this headquarters just at the time a move was in process, and the issuance of the order at that time was overlooked. Please inform us what means should now be taken to regularize the situation.
