Dott. Base of Ascoli is, in possession of a letter from the Provincial Commissioner of Ascoli informing him of his nomination as Prefect; while Dott. De Goyzueta of Pesaro states that he assumed the duties of Prefect on verbal orders, and can produce only a telegram from the Minister of the Interior, addressed to him as Prefect of Pesaro, informing him of his appointment as Prefect 1st. Class.
