Maj. Ralph R. Temple spoke with Col. Menapace, Director, Finance S/C and read the telephone message from Vicedomini and Catenacci to him. Col. Menapace said that the telegram of Oct. 22 left it up to the local bodies to decide on whether the advances were to be given. In any event Decree N. 722 of 21 November published in Gazzetta Ufficiale N. 143 of 29 November 1945 cures the situations. Col. Menapace will cable or call Lt. Col. Timmons, D/Dir. of Finance who is at the Milan RCs' meeting and have him discuss it with RCs.

I suggested Col. Menapace also to cable RC's office in Padua informing them of the situation, also to arrange with legal S/C for the immediate implementation of the decree in a special edition of the G.U. I would call the Minister of the Interior and explain the situation authorizing them to cable Treviso Prefect and others to calm and set out the position.

Dr. Catenacci said also that a similar strike is impending in the province of Milan.

1. Subject is D.L.L. 21 November 1945 No 722 appearing in No 143 of the Gazzetta Ufficiale dated 29 November 1945, which increases salaries and pensions of Statel and Parastatal employees. Refer to Memorandum Finance Sub-Commission 13065/F of 13 April 1945, Memorandum Finance Sub-Commission 13065/F of 2 May 1945 and Memorandum Finance Sub-Commission 13065/F of 13 August 1945, for information concerning D.L.L. of 13 March 1945 which is the previous legislation upon this subject.

2. This new Decree provides for:

- (a) Increase in basic pay. This increase is on a step rate basis ranging from 130% on the first 10,000 lire per year to 60% on salaries above 60,000 lire per year. The minimum total increase is 2,300 lire gross monthly.
- (b) The "razione viveri" (now called Carovita) allowance is increased to a sum ranging from 6000 lire monthly to 3750 lire monthly depending upon the population of commune where the employee is employed. This is also scaled down on the basis of dependency.
- (c) The Carovita allowance will be adjusted every 3 months in accordance with fluctuations in the cost of food.

1. Subject is D.L.L. 21 November 1945 No 722 appearing in No 143 of the Gazzetta Ufficiale dated 29 November 1945, which increases salaries and pensions of Statal and Parastatal employees. Refer to Memorandum Finance Sub-Commission 13065/F of 13 April 1945, Memorandum Finance Sub-Commission 13065/F of 2 May 1945 and Memorandum Finance Sub-Commission 13065/F of 13 August 1945, for information concerning D.L.L. of 13 March 1945 which is the previous legislation upon this subject.

2. This new Decree provides for:

- (a) Increase in basic pay. This increase is on a step rate basis ranging from 130% on the first 10,000 lire per year to 60% on salaries above 50,000 lire per year. The minimum total increase is 2,300 lire gross monthly.
- (b) The "razione viveri" (now called Carovita) Allowance is increased to a sum ranging from 6000 lire monthly to 3750 lire monthly depending upon the population of commune where the employee is employed. This is also scaled down on the basis of dependency.
- (c) The Carovita Allowance will be adjusted every 3 months in accordance with fluctuations in the cost of food.
- (d) The "agguanto di famiglia" (Family Allowance) is abolished and in its place there is an allowance of 900 lire per month for the first dependent and 300 lire per month for each additional dependent. This will be paid as a supplement to the Carovita.
- (e) The "integrazione temporanea" (temporary integration) is abolished, having been absorbed in the increases in the basic pay.

3. The increases provided are effective from 1 October. This Decree is being implemented for application in AMG territory. Advances in anticipation of this Decree have already been granted, both in Italian Government and AMG territory beginning with the month of October.

4. All figures given are gross before deduction, and are applicable where seals are not provided by the State.

5. Attached hereto is a chart showing application of this Decree to 5 selected categories of Government employees.

6. Employees of the Provincial and Regional Labour Offices will be treated separately.

7. This Memorandum has the concurrence of Finance Sub-Commission.

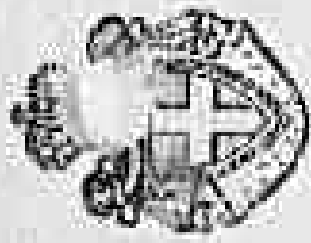
