Your Excellency :

1. Referring to your letter of the 12 March (5000/81) and to subsequent correspondence I append the contents of a letter received from the Provincial Commissioner of Arezzo regarding Archivist Capo RIGOTTILLI, Gaetano of that Prefettura.

" In spite of the fact that Capo Archivist RIGOTTILLI Gaetano is over 70 years of age, he is doing useful work in supervising the archives of the Prefecture, and his practical knowledge and capacity for work is very valuable in the reorganization of the archives made necessary by their partial destruction during operations in AREZZO.

There is no objection, however, to the retirement of RIGOTTILLI provided that a chief archivist capable of continuing the work started by him is sent in replacement."
