The Comm. Dr. Vincenzo SALERNO, formerly President of Police (Questore) of the Commune of Enna, was arrested on July 22<sup>nd</sup>. 1943 by the Allied Police and in consequence of this, according the information of the family, he turned to His Excellency the Chief of Government asking <sup>him</sup> for support because he is interned in the Camp "D" C.S.S. Mecheria (Sud. Oranais).

Therefore I beg to examine the situation (position) of the functionary mentioned above also in view of the reasons which have caused the arrest at that time for deciding, if possible, his liberation and his return home.
