The prefect of Apuania has made representations on the serious situation of lodgings in that Province especially damaged by the long waging of the war on its territory.

The Ministry of Postwar Assistance, with which the matter has been taken up, pointed out that it has not yet been possible to set up sufficient lodgings for the refugees and evacuees in that region.

In order to avoid a worsening of the difficulties in which the local populations find themselves, the Prefects of the Provinces turned over to the Italian Government administration have been invited by circular, copy of which is attached hereto, to try to persuade the interested parties to delay their return to Apuania where there are no possibilities of settling them.

We are kindly asking your Commission to examine the possibility of forwarding the circular also to the Prefects of the Provinces of ~~the~~ Northern Italy.

Subject : Recovery of records transferred to Northern Italy

With reference to the restitution of the archives records transferred to Northern Italy to their normal offices, on the basis of the report submitted by the representative of this Administration who recently took part to the meetings held in Milan and to the surveys of the existing records, we establish as follows:

- 1) Archives records pertaining to this Administration will continue, as a general rule, to be kept in safekeeping with the present holders, who will take care of the crating, the loading and the transport to Rome, where formal delivery will take place. In the event that the loading and the transport must be carried out in various stages, they shall appoint some of their dependent officials to escort the shipments preceding the last one.
- 2) In the operations of crating, loading and transport of the records located in Venice, the consignee of the material shall be assisted by two police employees of the Direzione Generale di P.S. will provide in time, as soon as it will be notified of the arrival on the spot of the caisses and cratings for the printed material existing there.
- 3) The Direzione Generale of the Fire Brigade Services will be permitted to transport by their own means the material laying in Milan;

For this purpose some of the motor vehicles of this Ministry which have already been recovered in the North could be utilized. Count Annoni is therefore kindly requested to get in touch with the proper organs.
- 5) All convoys, including those affected by motor vehicles, must be escorted by armed guards.

Subject: Recovery of records transferred to Northern Italy

With reference to the restitution of the archives records transferred to Northern Italy to their normal offices, on the basis of the report submitted by the representative of this Administration who recently took part to the meetings held in Milan and to the surveys of the existing records, we establish as follows:

- 1) Archives records pertaining to this Administration will continue, as a general rule, to be kept in safekeeping with the present holders, who will take care of the crating, the loading and the transport to Rome, where formal delivery will take place. In the event that the loading and the transport must be carried out in various stages, they shall appoint some of their dependent officials to escort the shipments preceding the last one.
- 2) In the operations of crating, loading and transport of the records located in Venice, the consignee of the material shall be assisted by two police employees that the Direzione Generale di P.S. will provide in time, as soon as it will be notified of the arrival on the spot of the caisses and cratings for the printed material existing there.
- 3) The Direzione Generale of the Fire Brigade Services will be permitted to transport by their own means the material laying in Milan;
- 4) To provide for the prompt dispatch which appears to be the most urgent one, of the 84 caisses containing the serial records of all the personnel of the Civil Administration and the archive files for personnel of Group A located at Virle Tre Ponti (Brescia) effecting the transport by motor vehicles.
