1. I relayed the content of Your Excellency's note No. 3799 of 14 June 1944 to the Legal Subcommission.

2. In connection with the preparation by the Minister of Justice of a decree dissolving formally all fascist institutions, the Legal Subcommissions handed to the Minister for his consideration a list of purported fascist institutions as reported to that subcommission from various sources. The name of "Gruppo dei Fascisti Universitarii" reported to be operating in Sicily as "Federazione Universitaria Cattolica Italiana - F.U.C.I." was contained in such list. But no effort has been made by the Legal Subcommission to have Catholic University Associations or F.U.C.I. as such dissolved.

3. Inquiries have been made of the Minister of Justice concerning the progress of the proposed decree from time to time and the above matter has never been mentioned at any conference between him and the Legal Subcommission.

The Legal Sub-Commission has proposed to the Ministry of Justice the dissolution of the Catholic University Associations.

The news that the same proposal has been made by the Education Sub-Commission has aroused great concern in interested circles.

I would be particularly grateful if you would inform the two Sub-Commissions that are dealing with this question, of the following:

1. The University student associations are guaranteed by the Concordat between the Holy See and the Italian State.

2. During the fascist dictatorship they have carried anti-fascist activities against fascist university groups relentlessly. As a result, each of their members has been subjected to slander and persecutions which have never crystallized in the suppression of the organization, because of what has been said in No. 1.

3. Finally, they have always kept the flame of the Universities' free thought burning, and have constituted the only refuge for young intellectuals who flee from the currents of extremest circles.

4. An eventual measure dissolving them would have unfavorable repercussions on the bulk of catholics, and would prove to be contrary to the principles of freedom which have been reaffirmed in Italy. *C22*

4) un eventuale provvedimento di scioglimento avrebbe sfavorevoli ripercussioni sulla massa dei cattolici e sarebbe in contrasto con la riaffermazione in Italia dei principi di libertà.
