TO : VP Civil Affairs Section.

1. I have the honor to report my return from East Africa and Cairo. I attach herewith a schedule of my journey for your information.

2. In this connection, I would point out that it is essential that an officer should carry with him from this theater a certificate to the effect that he has been inoculated against yellow fever. I had the greatest difficulty in getting an exemption certificate signed and it was certainly only due to the personal kindness of Major General C. A. Dowler, Middle East Command, whom I knew personally that I was able to proceed with my journey. I have informed AFHQ to this effect personally.

5. I can only state that I trust my visit has had the effect of stirring people up in regard to the desire of the Displaced Persons Sub Commission that some concrete action will be taken to accept their own nationals. 1377

6. All these officers were interested in Movements, but I can only here again state that I made it very plain that Movements was not our affair. Col. Jameson, however, said that he trusted Movements appreciated that there

was a reserved area consisting of the Ogaden Province of Somalia, the Odo area of Upper Juba and the reserved area of Miredawa which were not under the Ethiopian Government.

7. Sir Charles Lockhart stated that insofar as East Africa was concerned that he, in the name of the Governors responsible, was prepared to accept all nationals as soon as they receive their particulars. He stressed the fact that screening and thorough screening was essential and that on arrival in their territories, he would not consent to their release and dispersal therefrom until such time as their own local Security had given them the o.k. (sic). It may be said that all the officers whom I interviewed echoed Sir Charles Lockhart's views.

8. It is extremely difficult to get the Abyssinian Government to move, and I spent a considerable time with the Abyssinian Minister in Cairo, who promised me he would take immediate action and make the matter one of priority. The schedules sent by the Displaced Persons Sub Commission are now in the hands of all concerned and the Middle East is awaiting their acceptance.

9. It is obvious that Eritreans will have to go to Massawa. This latter will, of course, be dealt with by Movements. The local officers presumed that all Somalis would go with the Ethiopians to Djibouti.

10. The only other point that arose is to the effect that the officials of the territories concerned would prefer to have rather more ample details than are at present supplied on the lists prepared by Displaced Persons. For instance, it is not really enough to say that a man is a "Bravano" or an Italian Somali. If possible, his tribe and sub-tribe should be ascertained and stated. They would also like, if possible, to know the reason of why and how the adult males concerned came to Italy. This, I may say, is possibly the most important point of this report.

11. I regret the brevity of this report, but time did not allow of a fuller treatment of the whole subject, as in order to do so, I should have necessarily had to fly to both Asmara and Addis Abbeba, which I did not think was justified under the circumstances.

FIELD CENSORSHIP - CARRYING OF PRIVATE CORRESPONDENCE BY HAND

Extracts from M.E. G.O.'s 1661 of 1942 and 88 of '43 are reproduced below:-

TO DESTINATION WITHIN THE M.E.F.

- (a) Each parcel or letter must bear a full official address of the sender and the name and full postal address of addressee.
- (b) Each letter or parcel must be submitted to Unit Censorship, and be impressed with the Unit Censor Stamp. Photographs and undeveloped films will not be included in letter or parcels when they are carried by hand.

TO DESTINATION OUTSIDE THE M.E.F.

- (a) Each parcel or letter must bear the name and full postal address of addressee.
- (b) Each letter or parcel must be submitted for BASL Censorship, and be impressed with the Censorship Circular release stamp bearing the words "Deputy Field Censor" before departure.
- (c) A permit for the number of items carried must be held. Correspondence to be carried by hand will be sent or taken by hand on the responsibility of the carrier to reach any of the following bases censorship offices at least 48 hours before the carriers departure:-

NOTICE TO INTENDING AIR PASSENGERS

Your attention is directed to the following instructions with which every air passenger is required to comply:—

1. BAGGAGE.—Personal baggage is restricted as follows:—

On B.O.A.C. and R.A.N.A. aircraft	—	—	—	44 lb.	
On Service aircraft	—	—	—	—	40 lb.

All packages will be labelled with passenger's name and destination. Passengers are requested to keep kit required for night stops separate and to note that long trousers and long sleeves will be worn after sunset. Failure to comply with this instruction will lead to passengers being refused permission to enter messes, etc.

2. CAMERAS.—Cameras will not be taken outside E.A. Command by military personnel travelling by air without the authority of D.D.M.I., H.Q., E.A. Command. Those desirous of obtaining such authority will make written application direct to Chief Censor, E.A. Command, giving full particulars of the camera, including No., Lens No. and details of any spare lens. The latter may issue the necessary permit. Cameras for which permits have been so obtained will either be carried inside the passenger's baggage or handed over to the Captain of the aircraft, whether civil or military, for safe custody.

In no circumstances will loaded cameras be allowed on board an aircraft.

Military personnel are absolutely forbidden to take photographs from an aircraft.

3. CURRENCY.—Not more than £10 (ten pounds) may be taken out of East African territories.

4. HAND-CARRYING OF CORRESPONDENCE.

(a) **Private Mail.**—Passengers proceeding outside E.A. Command are prohibited from carrying any private correspondence, i.e., letters, postcards, parcels and photographs, except and unless such matter has been submitted for Base Censorship to Chief Censor, E.A. Command, has been impressed with the Base Censorship stamp, and is accompanied by a permit from the Chief Censor, E.A. Command, for the number of items to be carried.

Passengers moving within E.A. Command may carry such correspondence, etc., provided that it bears a unit censor stamp and is certified for carriage by hand.

(b) **Official Mail.**—The instructions laid down in para. 16 (a) (viii) of the Supplement to G.R.O. 3733 will be strictly adhered to.

5. IDENTIFICATION.—All officers will be in possession of valid Identity Cards. Other ranks will carry A.Bs. 64, Part I.

Should an Identity Card be withdrawn from an officer proceeding on transfer to U.K., he will personally be responsible for obtaining a temporary Identity Card from the officer withdrawing the permanent card.

6. MEALS AND ACCOMMODATION.—Food and accommodation are not included in the facilities provided for passengers travelling by Service aircraft, but every facility is accorded by the Service concerned to obtain food and accommodation in messes, etc. Any accommodation, refreshments, etc., provided for passengers travelling in Service aircraft must be paid for by the passenger.

In cases where meals or refreshments are actually required on Service aircraft, passengers will provide such under their own arrangements.

Meals and accommodation are provided when travelling by B.O.A.C. or R.A.N.A.

7. MEDICAL.—All passengers will be in possession of, and produce on demand, valid certificates of vaccination against Smallpox and inoculation against Yellow Fever. Periods of validity are as follows:—

Smallpox Certificate. Not less than 14 days nor more than 2 years old. (In the case of personnel proceeding to Nigeria, certificate will not be more than 1 year old.)

Yellow Fever Certificate. Not less than 15 days nor more than 2 years old.

Certificates in Officers' Service Books and A.Bs. 64 will be accepted, provided such are signed and dated by a Medical Officer.

8. NEUTRAL TERRITORIES.—When travelling on aircraft routes which pass through neutral territories, e.g., Portuguese East Africa, Portugal, etc., passengers are required to wear civilian clothes and carry valid passports visaed by the Consul of the country concerned. No evidence to indicate that passengers are Service personnel will be allowed to be apparent at any time.

9. SICKNESS.—Passengers liable to air-sickness are warned that no receptacles are provided on Service aircraft.

10. SMOKING.—No smoking is permitted by passengers in Service aircraft, nor on the tarmac on airfields.

In civil aircraft smoking is only allowed as authorised in the regulations of the controlling Corporation or Company.

N.B.—All passengers are warned that failure to report to Movement Control at the airfield at the time stated on the Route Form or as ordered by Mov/Tn, Command H.Q., may result in the cancellation of the passage.

PROBLEMS OF DISPLACED PERSONS, STATELESS
PERSONS AND THEIR REPATRIATION AND TRANS-
FER IN THE MEDITERRANEAN THEATER OF OPERATIONS

PRELIMINARY

This draft paper is an attempt to bring the problem of displaced persons in the Mediterranean Theater of Operations into focus. It is consistent with and to a certain extent based upon the plans made by Supreme Headquarters and Allied Expeditionary Force and by Military Headquarters (Balkans), and incorporates information received from these Headquarters. It is intended as a statement of the problem by the Advisory Committee to ensure uniformity of thought and make certain recommendations to which the attention of the Supreme Allied Commander may be invited. At this stage the status of this paper is that of an unofficial draft for discussion.

I. OBJECT

The repatriation and resettlement of displaced persons within the Mediterranean Theater of Operations as soon as possible. In order to achieve this object, and control of movement, registration, collection in assembly areas, care and maintenance therein is essential.

II. DEFINITIONS

Displaced Persons. There are three classes of displaced persons:

- a. Civilian nationals of united or enemy nations or others who are to be repatriated.
- b. Civilians of such nations who are to be returned to their places of previous residence, not being nationals of the country of that residence.
- c. The stateless (in law or fact) for whom a place of temporary or permanent residence needs to be found.

Repatriation. The restoration of displaced persons to the State to which they belong. Such persons are the civilian nationals of united, enemy and neutral nations who either must be, or desire to be, returned to the State to which they belong. Included are all persons other than prisoners of war and those whose status may be defined by the Supreme Allied Commander as ex-prisoners of war.

Transfer. The transfer of stateless persons to their temporary or ultimate destination.

III. ANALYSIS OF THE PROBLEM.

Estimates of the numbers of displaced persons in Europe vary considerably. The latest figures which concern the Mediterranean Theater of Operations are summarized as follows:

c. Within the countries concerned and within the theater as a whole,
there is a further considerable problem of actual displacement. For example:

1. In Greece it is estimated that up to 500,000 Greeks may have
been the victims of internal displacement, of whom up to 150,000
may be totally destitute.

2. In Yugoslavia there has been considerable internal population displacement; Serbia has lost some 70,000 Croats "repatriated" to Croatia, and gained about 350,000 Serbs from other sections of Yugoslavia. Croatia lost about 20,000 Bosnian Germans and 3,000 Magyars and its Serbian minority was decreased by 15-20%. It gained the 70,000 Croats mentioned above, and in addition several thousand Germans "Repatriated" from the South Tyrol, Bukovina and Bessarabia.

- d. Stateless Persons. There do not seem at present to be any approximately reliable figures available.

IV. RESPONSIBILITIES.

The responsibilities for dealing with the above vary considerably according to the status of the indigenous governments in the various countries within the Mediterranean Theater of Operations.

- a. In general, it will be desirable for the responsibility of Allied Force Headquarters to be similar to the responsibility of SHAEF in the areas respectively under their control.

c. g. The responsibility of SHAEF in the operational zones has been defined as follows: To prevent any hindrance to military operation or military government which might be occasioned by the massing, control, or movement of displaced persons. To prevent or control outbreaks of disease among displaced persons. To relieve as far as practicable, conditions of want among Allied displaced persons and to relieve, as necessary, destitution among enemy displaced persons.

- b. The responsibility of Government in Liberated Areas has been defined by SHAEF as follows:

1. They will normally have full responsibility for displaced persons and refugees and for their own nationals returned to their countries by Allied Military authorities.
2. They should make available specialist personnel to issue repatriation visas and help as necessary in controlling their displaced nationals.
3. They should issue "stand fast" instructions and instruct the frontier guards to direct into Assembly Centers or Processing Centers persons attempting self-repatriation. They will as far as possible ensure that a uniform theater policy is carried out for dealing with displaced persons, including registration and reciprocal acceptance of registration and medical clearance records. There should be an agreement to accept and interchange liaison officers to assist in the supervision and control of displaced persons of their own nationality and who will be empowered to issue repatriation visas. There must be agreement to admit to their territory all their former nationals who may have been displaced by the war into other countries without discrimination on account of race, religion, or political beliefs.

d. Stateless Persons. There do not seem at present to be any approximately reliable figures available.

IV. RESPONSIBILITIES.

The responsibilities for dealing with the above vary considerably according to the status of the indigenous governments in the various countries within the Mediterranean Theater of Operations.

- a. In general, it will be desirable for the responsibility of Allied Force Headquarters to be similar to the responsibility of SHAEF in the areas respectively under their control.

c. g. The responsibility of SHAEF in the operational zones has been defined as follows: To prevent any hindrance to military operation or military government which might be occasioned by the massing, control, or movement of displaced persons. To prevent or control outbreaks of disease among displaced persons. To relieve as far as practicable, conditions of want among Allied displaced persons and to relieve, as necessary, destitution among enemy displaced persons.

- b. The responsibility of Government in Liberated Areas has been defined by SHAEF as follows:

1. They will normally have full responsibility for displaced persons and refugees and for their own nationals returned to their countries by Allied Military authorities.
 2. They should make available specialist personnel to issue repatriation visas and help as necessary in controlling their displaced nationals.
 3. They should issue "stand fast" instructions and instruct the frontier guards to direct into Assembly centers or Processing Centers persons attempting self-repatriation. They will as far as possible ensure that a uniform theater policy is carried out for dealing with displaced persons, including registration and reciprocal acceptance of registration and medical clearance records. The position of UNRRA so far as relief and rehabilitation in Greece, Albania and Yugoslavia is governed by directives issued by HQ Balkans based on an agreement dated the 3rd of April 1944.

2. In enemy territory UNRRA will assume responsibility for the care and relief of allied displaced persons at a time and to the extent to be determined by the Supreme Allied Commander.

d. The responsibility of Intergovernmental Committee on Refugees (I.G.C.R.) has been defined as follows:

The Committee will continue its responsibility for persons who have been obligated to leave their home for reasons of race, religion or political belief and who cannot be or do not desire to be repatriated. It is believed that UNRRA will be prepared to assist for a reasonable period in the care of such persons as cannot be repatriated until the I.G.C.R. is prepared to help remove them to new places of settlement.

e. The responsibility of the International Red Cross and other foreign voluntary societies has been defined as follows:

1. International Red Cross will facilitate dispatch and receipt of communications to, from and about displaced persons.
2. Foreign voluntary societies will have responsibility for relief and welfare at a time and to an extent to be determined by the Supreme Allied Commander. They will be required to work in collaboration with UNRRA whenever the latter is at work in the area concerned.
- f. The responsibility of enemy governments has been defined as follows:
 1. Enemy authorities should be required to carry out the following functions as directed by Military Commanders:
 - a. Be responsible for the care, shelter, maintenance and medical attention required by Allied displaced persons in the territory.
 - b. Be responsible for the care and control of enemy displaced persons.
 - c. Be responsible for ensuring that wages and benefits to Allied displaced persons who were or are workers in the territory and remittances to their family are paid when due.

 - e. Be responsible for the production on demand of lists of workers in internment and concentration camps and lists of places of confinement of political prisoners, their location and the character and nature of accommodation.
 - f. Be responsible for the release of food, sanitary, medical and clothing stocks held in the territory.
 - g. Be responsible for setting up assembly centers for enemy and satellite nationals displaced within the territory.
 - h. Be responsible for setting up reception centers as required for repatriating enemy nationals.

 - i. Be responsible for dissemination of "stand fast" orders for displaced persons and for the passing on of the Supreme Allied Commander's instructions to Allied, enemy or Satellite displaced persons in their territory.

V. METHODS OF ACHIEVING OBJECT.

The various plans for the methods to be adopted in the areas inside the Mediterranean Theater of Operations will differ somewhat in each case. Some of the more important points are suggested below.

a. Traffic Control

It may be necessary to require evacuation, in whole or in part, of selected frontier towns for use as Assembly Centers to which displaced persons attempting self-repatriation may be directed.

Military Commanders will presumably determine the routes which may be utilized and establish traffic control machinery to keep the routes required for military traffic clear. Military Commanders will presumably direct and control the movement of displaced persons within formation areas, employing military police and troops until indigenous police can be organized.

- It will be necessary to provide suitable signs designating or pointing the way to highway routes, information bureau and assembly centers. Military Commanders should ensure that an Information Bureau should be set up in any area in which there are large numbers of displaced persons and furnish such Information Bureau with all available intelligence.

Displaced persons should be given an opportunity to join the armed forces of their country if represented in the Theater, or to serve in labor battalions organized by the military provided their loyalties to the Allies have been determined and they qualify physically and otherwise.

Movement will be strictly controlled under direction of Allied military authorities. Frontier guards will be used to reinforce indigenous frontier control personnel at Border Control Stations. Displaced persons who arrive at Border Control Stations without proper documentation will be directed back to the nearest Assembly Center.

c. 1. Processing or Accommodation Centers.

Assembly Centers and Reception Centers will be accommodated in areas, so situated as to afford a direct route to and from recognized frontier crossing points. (Border Control Stations). Both Assembly and Reception Centers may be established within one area; for example, one accommodation area in North-Eastern Italy might serve as an Assembly Centre for displaced Poles in Italy, and also as a Reception Centre for displaced Italians returned from Germany. Border Control Stations, which will not provide accommodation, will be situated on or close to the frontiers on the direct route to and from the Assembly and Reception Centers. Displaced Persons will be channelled from Assembly Centres to Reception Centers, across the frontier, through the Border Control Stations, under supervision.

Both Assembly and Reception Centers may be established within one area; for example, one accommodation area in North-Eastern Italy might serve as an Assembly Centre for displaced Poles in Italy, and also as a Reception Centre for displaced Italians returned from Germany. Border Control Stations, which will not provide accommodation, will be situated on or close to the frontiers on the direct route to and from the Assembly and Reception Centres. Displaced Persons will be channelled from Assembly Centers to Reception Centers, across the frontier, through the Border Control Stations, under supervision.

It will clearly not be desirable to accommodate enemy and allied displaced persons in the same Processing Centers and the operation of normal Processing Centers, should be modified as required for enemy nationals, probably on the lines of detention camps.

2. Assembly Centers.

The function of an Assembly Center will be the temporary care of displaced persons for whom both clothing and medical facilities will have to be provided until they can be given temporary gainful employment or be repatriated. It is here that clothing and shelter will be provided, disease controlled and emergency medical attention given, registration and security examinations performed, field Gross facilities employed to permit communication with the outside world, grouping arrangements made for accommodation and classification according to nationalities and desired destinations, and compilation of reports on presence and number of nationalities.

3. Reception Centers.

The function of Reception Centers will be for the purpose of receiving and providing temporary care for displaced nationals within the territory to which they have returned.

4. Border Control Stations.

It is suggested that these should be established as a military responsibility on civilian traffic routes at or near international boundaries for the control of movements across these boundaries of both individual travellers and Displaced persons. Displaced persons who have not been registered should normally be directed from the Border Control Station to the nearest Assembly Center where they can be processed and wait orderly for repatriation.

d. Registration and Returns.

It will be necessary that all displaced persons should be registered in a uniform manner, employing standard registration forms. It will be desirable to follow the procedure already prepared by SHAEF. It will also be necessary to make periodical reports and returns upon the resident population in the Assembly Centers.

e. Transportation Control

It will be of vital importance to control and coordinate transportation in all areas. In this connection, it is understood that a European Inland Transport Commission is likely to be set up, among whose tasks will be the provision and coordination of such transportation.

f. Supply.

The maximum use of local resources and organizations should be made. Where such are inadequate, the necessary provision will have to be made from military sources.

VI. PROBLEMS

It is clear from the above short summary that a number of problems will arise. Among them will be:

It will probably be thought desirable that liaison officers be exchanged between the Theaters as soon as possible.
- b. Coordination of transportation and movement. This is a major problem. It is not only a problem within the Theater, but also requires closest coordination with SHAEF in view of the many hundreds of thousands of displaced persons who will have to pass from one Theater to the other in both directions and also outside Europe.

c. Minimum standards of welfare and relief should be uniform in both theaters and policy as to a definite minimum adopted both by the military and by voluntary organizations.

d. Preparation will have to be made for large scale but unorganized attempts at self-repatriation. The ideal solution would be such rigorous control as to make individual action impossible, but experience has proved that no method of control can achieve that object. It must, therefore, be realized that although as strict control as possible should be imposed, yet arrangements to cater for individual wanderers running into many thousands must be made. The alternative will be vagrancy and banditry on an unprecedented scale, together with very serious medical and sanitary implications. One of the first steps to be taken might well be a coordinated "stand fast" propaganda.

e. The position of all non military assistance, particularly UNRRA, should be defined as early as possible. UNRRA's relations with the military are centrally determined and the Combined Civil Affairs Committee, as the agency of the Combined Chiefs of Staff, has been designated as the agency through which UNRRA's contact with the Combined Chiefs of Staff is to be maintained. SUBJECT: Repatriation of Nationals to EAST AFRICA.

TO : AMHQ G-5 Section.

1. Further to my letter of 4 October 1944, I now understand that travel routes will be arranged by Movements.
2. I consider, however, that the authorities should be closely consulted as follows, in regard to policy and allied incidental matters.

Ethiopians. The Abyssinian Minister at Cairo - The Sudan Agent at Cairo.

Somalis. The representatives at Cairo who are responsible for these Nationals.

Britons. The Resident responsible in Cairo for these Nationals.

EAST AFRICANS. His Excellency, the Governor of Kenya, or at his designation, the Chief Native Affairs Officer.

YEMINI ARABS, etc. The Resident representative at Cairo who is responsible for the Nationals of Palestine territories and those in its vicinity.

PORTUGUESE EAST AFRICANS, etc. The Secretary of the East African Governors Conference.

3. Col. Spicer will bring with him a schedule of the Nationals concerned and of their native locations. He will thereby be able to present a picture of the position as appreciated at this end.

SUBJECT: Repatriation of Abyssinians, Ethiopians and Somali Nationals.

TO : A.P.H.Q. (C-5 Section).

28 SEP. 1944

There are in this country, at present under the care of the Displaced Persons and Repatriation Sub-Commission a considerable number of Abyssinians, Ethiopians and Somalis etc. whom it is desired to evacuate to Africa as soon as possible. They of course wish to return to their own country. Many of them are at present in the same camps as Europeans as there are no suitable camps available in which they can be accommodated separately.

It is required to make immediate arrangements for the repatriation of these, and to discuss arrangements for the repatriation of other parties later on. In the light of past experience and in view of the somewhat complicated nature of these arrangements and the inevitable delays in ports and cables I strongly recommend that an officer be sent to arrange all details direct with the civil officials in Egypt and Africa (A.P.H.Q. Cable No. ME 66892 dated 23rd August 1944 addressed to Headquarters, Middle East Forces reffers).

Colonel R.C.B. KITCHER who had had considerable police experience in East Africa and who knows many of the officials there can be made available and I am desirous of sending him.

May authority be given for Colonel KITCHER to proceed to CAIRO and to MAURITIUS for this purpose and for air travel to be arranged for him. As the matter is of great urgency may a high priority be given for both outward and return journey.
