Statement of Salimbene Leonards

*Pointe*  
MESSINA 1

Born and living in Monreale.

In October 1943 he was appointed Mayor of Monreale by Allied Command of Liberation Forces, as he had the best moral and abundant qualifications.

He has administered his town diligently through great difficulty, ~~the population~~ <sup>very</sup> and without raising objections.

With ~~order~~ a provision of the Prefect n. 3879 of 1st June 1945 he has been replaced, <sup>apparently</sup> without any reason, by the super-forester of the place certain Gugli Leonards.

This Gugli Leonards had already been Mayor twice and now he is concealing his personality under the justification of demo-cratico.

He had already tried to avoid the appointment of the new Mayor by forwarding a statement of which he attaches a copy, to the Prefect and to the C. L. N. but he was no success. He was replaced and the old Poderia Faguta is now the mayor of his town with great astonishment of the population.

The statement was written when he heard the  
first rumors ~~of his~~ about his replacement.

The object is that he wants to ~~not~~ denounce  
a dangerous and ambiguous situation.

He never was a feminist and never belonged to the  
party or had its "temera". He was also condemned to  
"ammanizare" (sort of permanent control).

The man he is now mayor of the place is  
a 100% feminist and so is his family. When this person  
Poderosi she ruled the place together with a powerful  
group scorning the people. Many work against this Poderosi  
and be found in the registry of the Prefecture and at  
the Quarters of Messina.

Now this "ex feminist" and his family together  
with another large number of 100% feminists (indicated  
in the statement) are again ruling the town pretending

To be authentical Demo-cristiani - the fact the  
Region Demo-cristiani is actually governed by these  
people and none of the good citizens of the place  
including the Parson accepted to join the regions owing  
to the presence of the said gang.

# Dr. Salimbeni is now asking for justice  
and want this gang to be separated in the interest  
of the nation and of the down.
