1. The sums mentioned are not in possession of this Camp and there is no trace of them having been forwarded from other Camps. It is suggested that application be made to the Camps who issued the receipts.
2. The system used here regarding money of internees is as follows:-
 At the time of entering this Camp, any money held by Prisoners in excess of 50 Lire is taken from them, and receipt given. A record is kept of all such money taken, as well as any personal property or money handed over by previous P.W.Camps. All money etc so collected is kept in separate envelopes, one for each Prisoner, and on release such envelopes are handed back against receipts.

Prisoners monies taken from them should always accompany the Prisoner when transferred from one Camp to another.

The Camp Commandant of receiving Camp giving receipt for all packets handed to him. This procedure is general, and if the claimed amounts had accompanied the P.W., they would most certainly have had it handed back to them, on discharge.
