SUBJECT: Italian decrees.

24 April 1945

TO : Director, Legal Sub Commission.

1. I refer to the discussion at CA Section conference on Friday, 20 April 1945, with reference to the policy to peg wages, salaries and prices in Northern Italy as on 3 April 1945. Sub Commissions were directed to inform of any Decrees affecting the emoluments of Italian personnel for whom they are responsible which should be excepted from implementation in the North, in order to give effect to this policy.
2. This Sub Commission is concerned with purely administrative personnel of the Ministry of the Interior. I am not aware of any Decree affecting the emoluments of such personnel apart from other State officials. It appears from the index to the Gazzetta Ufficiale recently prepared and circulated by you that the following Decrees affect the emoluments of State officials, including those with whom this Sub Commission are concerned:
