TO: ALLIED COMMISSION - Local Governments S/C.

SUBJECT: Requisition of material belonging to the Ministry of the Interior,

In the month of december last Allied soldiers attached to Unit 362 R.E. Co. took away at repeated times material belonging to the Ministry stating they were proceeding to the requisition of the material in question by order of the Superior Allied Command.

Having taken up this matter with Claims and Hiring Sub Commission, the latter replied with the note which we are transcribing:

- "If the material in question is liable to be utilized for military purposes, then it may be subject to requisition, unless a special request is made to the Allied Commission.

We advise you to get in touch with the Allied Commission to forestall possible future requisition of materials, inasmuch as your Ministry may be deemed worthy of consideration. " -

You are therefore kindly requested to please interpose your good offices with a view of avoiding further requisitions, as the material is necessary for the reorganization of the services of the Ministry.

Your kind acknowledgment will be appreciated.
