Your Excellency,

1. I refer to your letter 167000-1/1 Dir. 1 Sec. 1 dated 31 October.
2. Information has now been received from the Economic Section Allied Commission that the entire matter is being handled by the "Istituto Centrale di Statistica" from which details are available to all Ministries.
3. The Prefecture have been and are still being visited by census takers, except in those provinces which are at present under Allied Military Government control.
The census takers visits will of course be extended to these latter provinces when the military situation permits.
4. In view of the information given in paras 2 and 3 it is thought that Prefetti are now certain of obtaining the necessary assistance in compiling the required returns and that no further action on the part of your Ministry is necessary.
5. I wish to thank you for the trouble which you have already taken to assist the Commission in this matter.

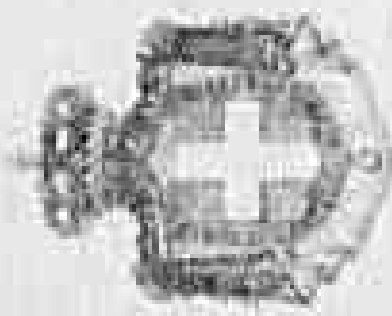

SUBJECT: Industrial Statistics

TO : His Excellency the Minister of the Interior

Your Excellency:

1. Certain statistical returns in connection with the Economic Section of the Allied Control Commission are required by the combined Chiefs of Staff.
2. To obtain the information desired, it will be necessary to compile questionnaire forms identical or similar to those used by the Istituto Centrale Statistico. The result should be useful to the Italian Government also, provided the forms are accurately and promptly compiled.
3. This Sub-Commission would welcome the issuance of an Administrative Order to all Prefects instructing that provincial and communal personnel be directed to assist in the compilation of the forms.
4. As the personnel in question is under Your Excellency's jurisdiction, I shall be pleased to learn that you will see that such an Order is issued.
