We assure to have arranged for the constitution of all the electoral Commissions and Sub Commissions for this Province, according to art. 11 of Ministerial Decree 24 October 1944. There are in total five Commissions and two Sub Commissions, detached in the following Communes which are the seat of a Judicial District:

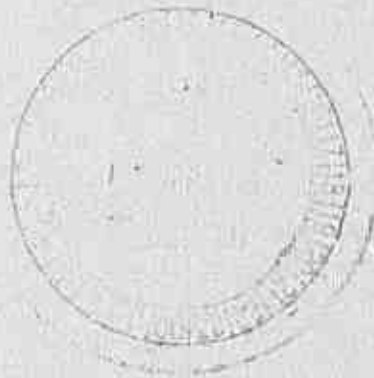

Since such a procedure, which after all is not in contrast with the provisions so far issued, is causing not only a substantial burden of expenses on the State budget owing to the necessity of paying out to the interested parties besides the allowance for attendance also the reimbursement of travel expenses and billeting expenses, but above all is interfering with the normal functioning of said Commissions which on account of the volume of their tasks will have to meet daily until their mission has been fulfilled, it was deemed opportune to ask Prefects to constitute, if possible, the said Commissions and Sub Commissions from citizens residing in the same commune.
3. For this purpose we have prepared the enclosed circular which barring any objections on the part of your Commission, we are kindly requesting you to have it distributed with all dispatch to the Prefects of the provinces still under AMG jurisdiction.
