TO: HIS EXCELLENCY THE PREFECT OF ROME

18 OCT. 1944

This Committee, composed of members of the Communist, socialist, Christian Democratic, and the Liberal and Action Parties, met for the first time on 23 August 1944 in the hall of the school building.

After reviewing the deplorable condition of the Town and there being no person capable in the slightest degree of safeguarding the interests of this Commune and seeing to the needs of the people, the Committee issued an order on the same day, appointing Sig. Ortensi Servizio Prefect Commissioner.

After examining the situation of Ortensi, and considering that one of the greatest difficulties which could prevent this appointment being approved could be only the fact that Ortensi is cousin to the self-re-signed Sindaco and former Mayor Rinaldi Ignazio, this Committee taking into account the excellent qualities and capacity of Sig. Buffoni Raffaele and that the people highly esteem and respect him, resolve by suffrage to propose to Your Ex. that the same Sig. Buffoni be appointed Prefect Commissioner.

We wish to inform you that Sig. Buffoni, besides being an experienced and cultured person, is the first and last partisan of the town who showed himself on various occasions capable of fighting and defying death, as the facts have proved and of which the whole population was testimony. He has been recognized as such by the Allied Police of occupation. (M.P.)

This Committee has always contributed in guarding the interests of the Commune and seeing to the needs of the people.

Until the approval of the appointment of Sig. Pereonti Ottavio became known, Trevignano could have been considered perhaps the only town, not only of the province but of the whole of liberated Italy, which had until then remained calm and quiet, both in regard to the people and the five parties which were collaborating in perfect harmony for the good of its citizens. ALLA COMMISSIONE ALLEATA DI CONTROLLO

Il giorno 23 agosto 1944, si adunava per la prima volta nell'aula dell'edificio scolastico, questo C.L.N. costituito dai membri dei seguenti partiti: COMUNISTA, SOCIALISTA, DEMOCRATICO CRISTIANO, d'AZIONE E LIBERALE.

Passando in rassegna la deplorabile situazione del Paese e non essendo persona alcuna che potesse almeno minimamente salvaguardare gli interessi di questo Comune e provvedere ai bisogni del popolo, il Comitato con verbale di adunata dello stesso giorno, deliberava il sig. Ortensi Servio Commissario Prefettizio.

Presa in esame la situazione dell'Ortensi, visto e considerato che una delle maggiori difficoltà che potrebbero ostacolare l'approvazione a tale nomina potrebbe essere il solo fatto che l'Ortensi sia cugino del dimissionario Sindaco già Podestà Rinaldi Ignazio, questo Comitato prendendo in considerazione le ottime qualità, la competenza nonché la grande stima e la simpatia del popolo, con deliberazione plebiscitaria propone all'E.V. il signor Buffoni Raffaele Commissario Prefettizio.

Vi si porta a conoscenza che il sig. Buffoni oltre ad essere titolato maturo classico risulta primo ed ultimo partigiano del Paese, che non una volta in base ai dati di fatto, di cui tutta la popolazione è testimone, ha saputo lottare e sfidare anche la morte. Come tale è stato riconosciuto dalla Polizia Alleata d'occupazione (M.P.)

Questo Comitato ha sempre collaborato per tutelare gli interessi del Comune e provvedere alle necessità del popolo.

Fino a quando non si sapeva l'approvazione a suddetta nomina del sig. Perconti Ottavio, Trevignano poteva considerarsi l'unico forse fra tutti i Paesi, non solo della provincia, ma di tutta l'Italia liberata che aveva fino allora mantenuto la calma e la tranquillità, sia da parte del popolo, come anche da parte dei cinque partiti che collaboravano in piena armonia per il bene del popolo. In seguito all'approvazione della nomina a Commissario del sig. Perconti Ottavio, si sono verificati in Paese dei veri malumori e malcontenti che hanno degenerato in dimostrazioni completamente ostili al Perconti, reclamando l'intero popolo diritto e giustizia.

Perché la cosa non si aggravi, preghiamo V.E. volere approvare la nomina a Commissario, il sig. Buffoni Raffaele, in caso contrario questo Comitato a scanso di ogni responsabilità, decide di dare le dimissioni.
