SUBJECT: Appointments of Commissioners for administration of various undertakings.
TO: See distribution list.

1. It has been noted that in the past many decrees have been published in the Gazzetta Ufficiale undertaking to appoint Commissioners and administrative heads for various Italian companies, institutions, etc. with power to act within the entire "liberated" territory i.e. in territory including the AGC zone. In at least one case the Commissioner has been expressly given power to administer a plant located in AGC territory (Decree of the Chief of Government 17 Feb. 1944 published in G.U. No. 22 of 26 April 1944).

2. It is hardly necessary to point out that none of the aforesaid appointments has any legal effect in AGC territory unless implemented by Executive Commissioner's endorsement published in the G.U. or otherwise made effective by the competent A.M.C. authority. It is for the individual Subcommissions to bring this fact to the attention of their respective opposite members in the Italian Government and to initiate whenever necessary the procedure for implementation in regard to decrees containing appointments which concern their respective field of control.





1. Your attention is drawn to the recital of RDLs to be re-enacted in AMG Territory.
2. Many of the laws referred to therein are not operative in Regions under AMG and some of them may be in contradiction with the legislation still in force.
3. On the other hand the R.D.L. itself may not make sense if the provisions of the law referred to in the recital are not taken into consideration.
4. Various solutions are set out hereunder.
 - (a) Revert to General Orders.
 - (b) Re-enact the legislation referred to in the recital (which may not be always possible)
 - (c) Extract from the Recital whatever is necessary to render the R.D.L. operative.
 - (d) Alter the text of the Executive Commissioner's order on each "Gazzetta" in such a way as to cover this problem of procedure.
