2. The implementation of the decree was signed by Brigadier LUSH on 29 July and the Gazzetta Ufficiale forwarded to Grosseto on 16 August. Therefore if it has been received by the Prefect, it is now the law of the land.

1. In an oral discussion with the Provincial Commissioner and Legal Officer, Grosseto, I Expressed reluctance to the issuance of temporary restraining orders by AMG as aids in enforcing Decree Law No 159. Whatever advantage may be obtained by such stop gap orders is offset by the vice of using the law of occupation in a field now set over to internal Italian law. Do you agree?

2. On the other hand, the internal Italian law should be invoked as early as possible so as to obviate the necessity of temporary aid from Occupational law. In the instant case, Grosseto Province is now under Region VIII. Can Decree Law 159 be made operative in Grosseto Province? As a matter of policy, should not such law be implemented in Provinces immediately on their reversion to Region Control?

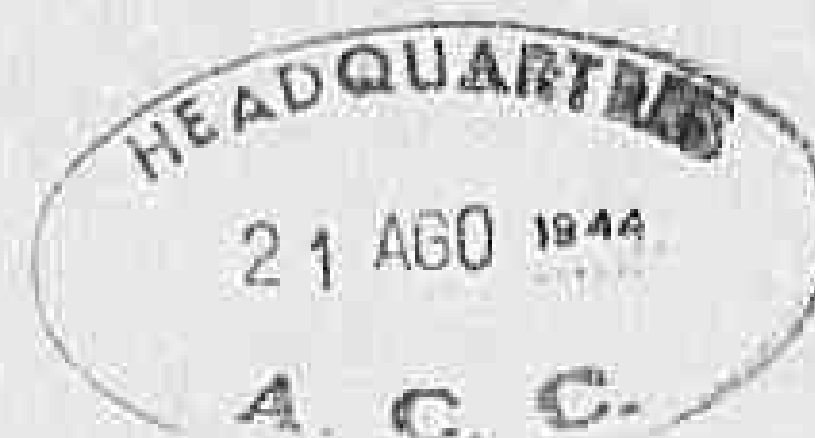

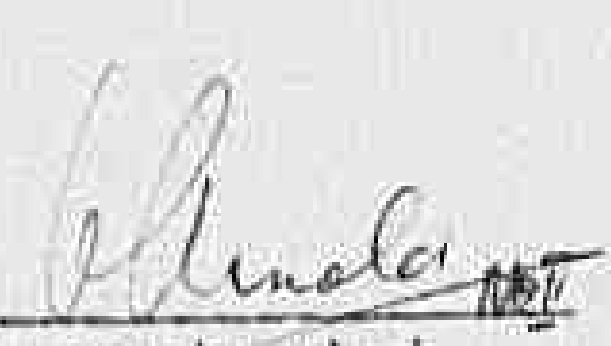

We understand the Executive Commissioner has made this endorsement.

2. Paragraph 3 of the directive states the legislation will become effective for a Province when copies are delivered to the Prefect, stamped with date, receipted for, etc.

The Province of Grosseto has recently passed into Regional Control. This is our argument that we be delivered this material for delivery to the Prefect, etc. as soon as possible. We are especially desirous that the Decree Law for the Employment of Fascist Italians become effective inasmuch as we have quite a few files compiled on Italians who will be prosecuted under this act in the District Court to be set up under the terms of the law. There are also cases wherein the property of Fascist officials (being expropriated) is being alienated or otherwise disposed of by the family. We handled one such case by giving the order for temporary seizure and vindictive action of the property, pending the action of the Commission to be set up under the law.

We are anxious to get the legislation on Bureau of the Province so the Italians can handle this business of theirs.

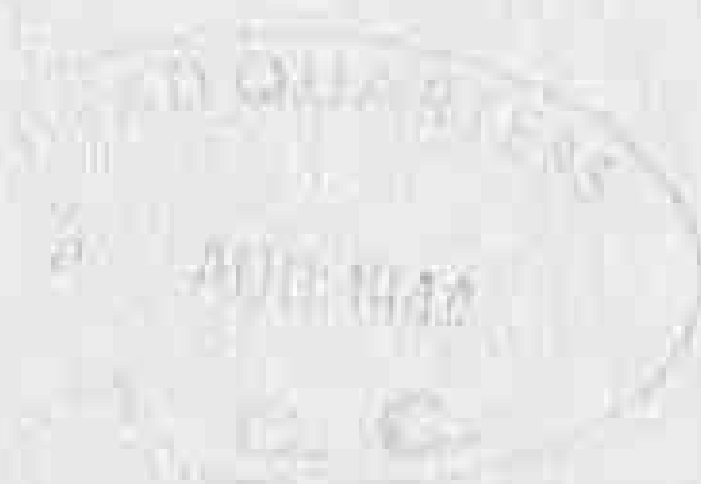

2. The collection of the Brindisi-Salerno legislation will be distributed for the present in the following Provinces of the Military Government Territory : TERAMO, AQUILA, PESCARA, CHIETI, ASCOLI, TERNI, VITERBO, RIETI, ROMA, (including Comune of Rome) FROSINONE, LITTORIA and Naples Comune.

3. The number of copies to be sent to each Province will be determined in accordance with the same criterion which was used in fixing the number of copies of Gazzetta Ufficiale which were sent to the Provinces of AVELLINO, BENEVENTO etc. before their restoration to the Italian Government.

4. Each packet will be provided with the following label :

5. The packet addressed to Naples will contain only such number of copies as is required for distribution in the Comune of Naples and will be addressed as follows :

6. The packets destined for Rome will contain number sufficient for distribution both in Rome Province and in the Comune of Rome. The address on the label will read as follows :

(for Prefect of Rome Province - to be distributed in Rome Province and Rome Comune).

7. The Provveditorato will advise this Sub-Commission when the packets are ready for dispatch. When so advised this Sub-Commission will forward to the Provveditorato 12 envelopes each of which will be addressed to one of the provinces set out above under 2 and each containing a receipt form in triplicate. These envelopes will be pasted or otherwise attached on the outside of the packets addressed to the respective Provinces. The packets will then be delivered by the Provveditorato to the Mail Dispatch Section of the HQ ACC at the Ministero delle Corporazioni First Fl or Room No.20.

8. The identical procedure will be followed in respect to the distribution of future issues of the Gazzetta Ufficiale and specifically both No.40. Each number of the Gazzetta Ufficiale will be packed separately for each Province by the Provveditorato.

9. The Minister of Justice in cooperation with the Ministry of Treasury will prepare a circular directed to the Prefects of the Provinces set out above under 2 and explaining the procedure of implementation and distribution of Gazzetta Ufficiale in Military Government Territory. This circular will in substance contain the provisions of the directive issued by this Sub-Commission a copy of which was transmitted to the Ministry of Justice. It will also follow in general the text of the circular issued by the Ministry of Justice to the Prefects of the recently restored Provinces. However, the following additional points should be included in the circular :

- a) a statement that the endorsement of the Executive Commissioner, ACC, extending the validity of the legislation reprinted in the aforesaid collection can be found on page 661 of the collection ;
- b) an explanation that the Prefect of Naples will be responsible for the distribution of the collection and of future issues of Gazzetta Ufficiale in Naples Comune and will sign the receipts therefor;

The above circular will be prepared and sent out immediately.

On June 6 the undersigned handed to the Ministry of Justice a set of Salerno Gazette for reprinting.

The necessary paper was made available from the reserve at the Ministry and the work entrusted to the "Tipografia delle Carceri".

On June 8 this establishment declared to be unable to carry out the work, because of shortage of gas.

Many printing establishments were then approached and the newspaper "IL POPOLO" agreed to undertake the printing. However on June 18, they had to give it up because no extra electric power could be conceded to them.

On 25 the "Poligrafico dello Stato" undertook the work and though they had only three hours of power per day the work proceeded slowly. Many difficulties were encountered but the first proofs were eventually ready on July 17 and sent to the Ministry of Justice for prior proof reading.

The Ministry has been requested to have 3000 copies ready by the evening of Sunday 21.

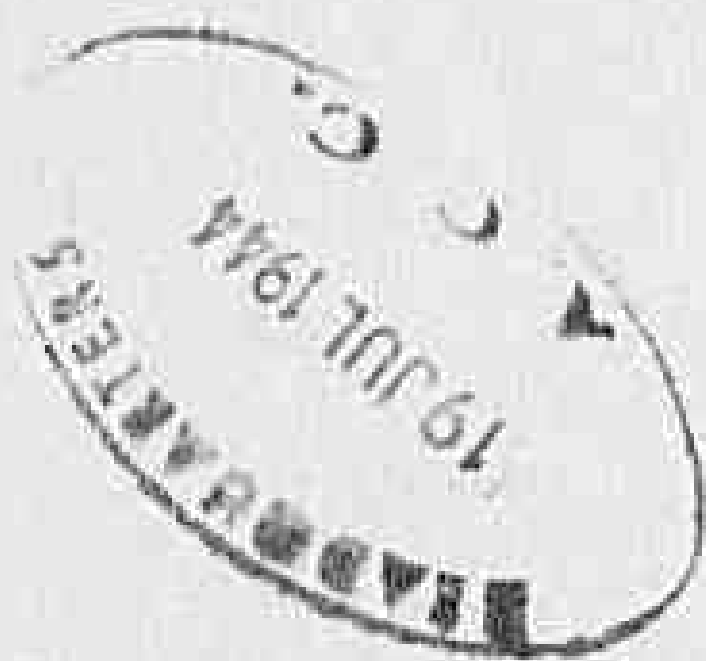

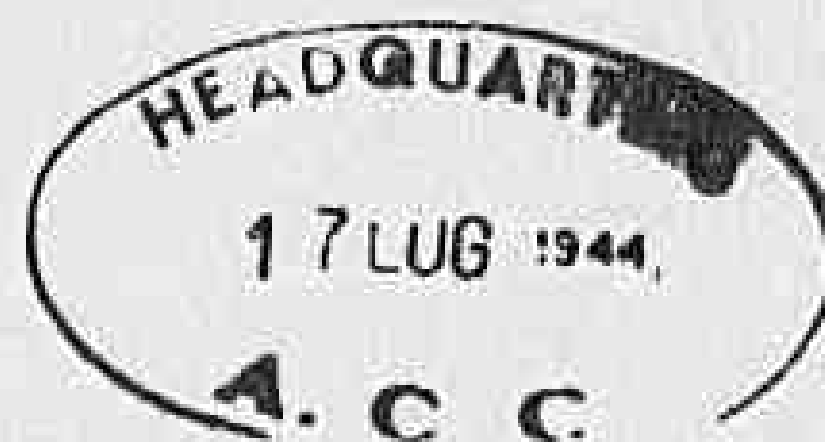

TO : Finance Subcommittee.

1. It is deeply regretted that no solution appears to be forthcoming in the above matter. A further memorandum from the Ministry of Justice is enclosed on the question of the printing of the Gazette.

2. Yesterday, 12th July the ACC representative responsible for the Poligrafico had an interview with the undersigned when it was stated:

(a) that both Chieruzzi and Mando were personal political friends of the Under-Secretary for War; hence his insistence on having them back to their posts;

(b) that their presence there was not necessary as there was no work for them to do;

(c) that the printing of the Gazzetta would require 30 (thirty) tons of paper;

(d) that there was not enough electricity at present to undertake the work.

May it be pointed out

(a) that the request for the recall of the two officials concerned has been made not by the Under-Secretary for War, but by Comm. Giolitti, "Directore" at the Ministry of Justice and whose department is responsible for the publication of the Gazette. He is a demochristian. His request has been strongly backed by H.E. Bassano who is a 'demedocrato del lavoro.'

(b) that all that is required is one ton of paper and that the Ministry of Justice is supplying it.

(c) that the enclosed memorandum puts this Subcommittee in an embarrassing situation and in the meantime this urgent work cannot be proceeded with. If it is impossible for the Poligrafico to undertake the printing entrusted to them 15 days ago, with or without Chieruzzi or Mando, could this Subcommittee be officially notified.

SUBJECT: Personnel of Poligrafico dello Stato (Chieruzzi and Mando)
Printing of Gazzetta Ufficiale.

TO : Military Subcommission.

1. It is deeply regretted that no solution appears to be forthcoming in the above matter. A further memorandum from the Ministry of Justice is enclosed on the question of the printing of the Gazzetta.

2. Yesterday, 22nd July the ACS representative responsible for the Poligrafico had an interview with the undersigned when it was stated:

(a) that both Chieruzzi and Mando were personal political friends of the Under-Secretary for War; hence his insistence on having them back to their posts;

(b) that there was no need for them to do so as there was no work for them to do;

(c) that the printing of the Gazzetta would require 30 (thirty) tons of paper;

(d) that there was not enough electricity at present to undertake the work.

May it be pointed out

(a) that the request for the recall of the two officials concerned has been made not by the Under-Secretary for War, but by Gen. Giolitti, "Director" at the Ministry of Justice and whose department is responsible for the publication of the Gazzetta. He is a demochristian. His request has been strongly backed by M. R. Bassano who is a democratic socialist lawyer.

(b) that all that is required is one ton of paper and that the Ministry of Justice is supplying it.

(c) that the enclosed memorandum puts this Subcommission in an embarrassing situation and in the meantime this urgent work cannot be proceeded with. If it is impossible for the Poligrafico to undertake the printing entrusted to them 19 days ago, with or without Chieruzzi or Mando, would this Subcommission be officially notified.
