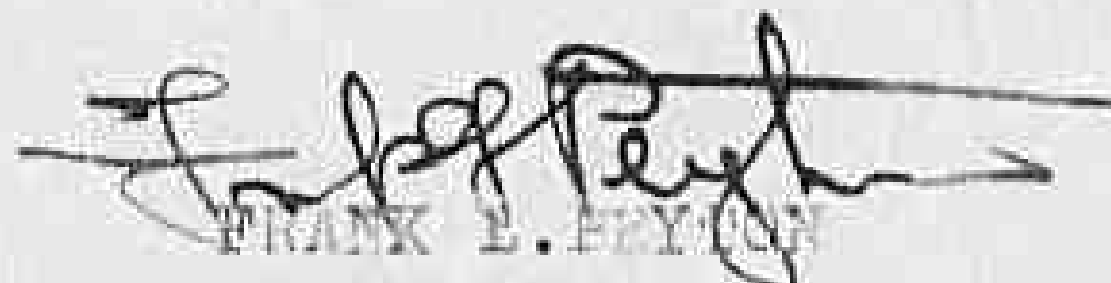

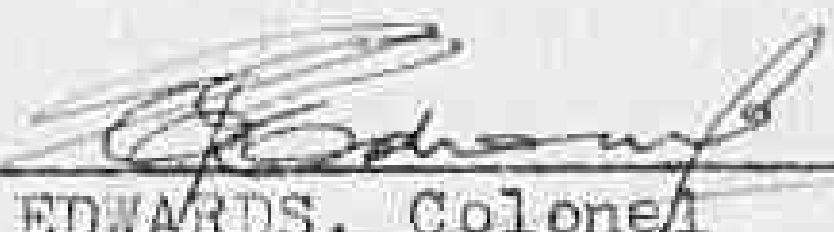

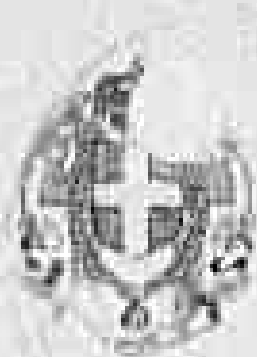

Royal Law Decree No. 146 of June 3, 1944 concerning the extension of Agrarian Lease Contracts expiring on or before December 31st, 1944. (Published in the Gazzetta, Special Series No. 36 of June 24, 1944.

It is our understanding that most of these contracts expire around September 10 and Lt. Col. Hamilton and the Regional Agricultural Officer (who visited us yesterday) are anxious that this law become operative as soon as possible.

I have advised them that we might deliver officially to the Prefect on behalf of ACC copies of the "Reactivation of Italian Agriculture pamphlet containing this law which was published by the Agriculture Sub-Commission. Quite a few of these have already been placed in the hands of the Prefect by someone. Couldn't this suffice in the place of the Gazzetta at least temporarily until the Gazzetta is received by us for delivery to him.

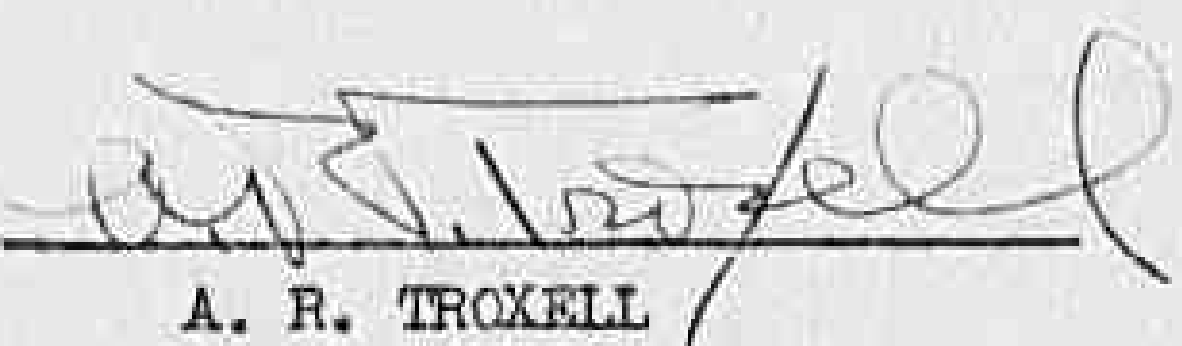

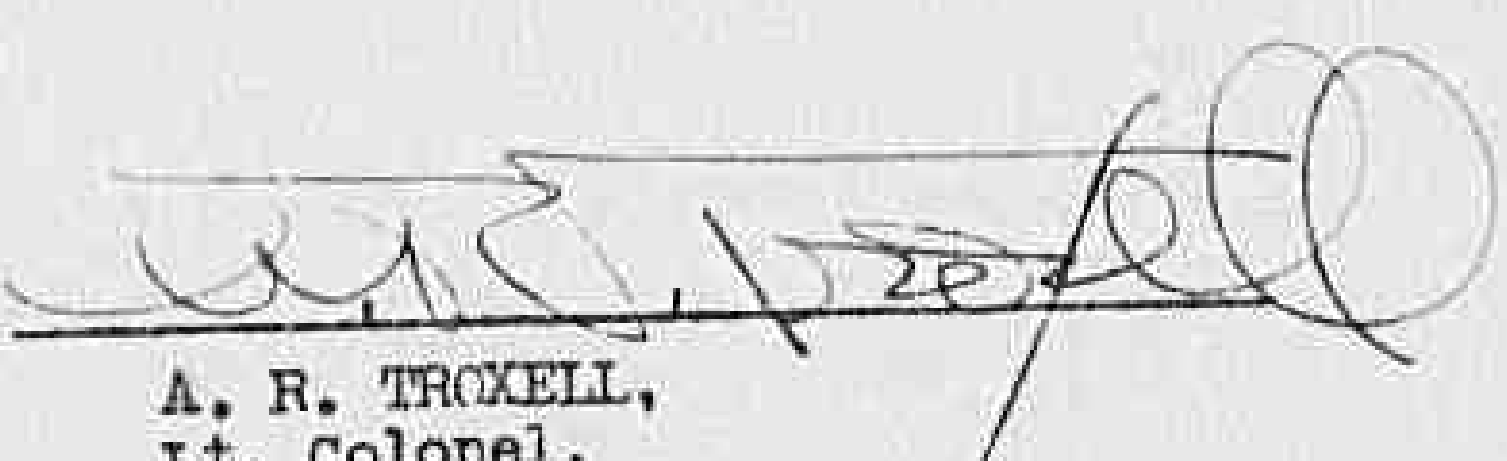
