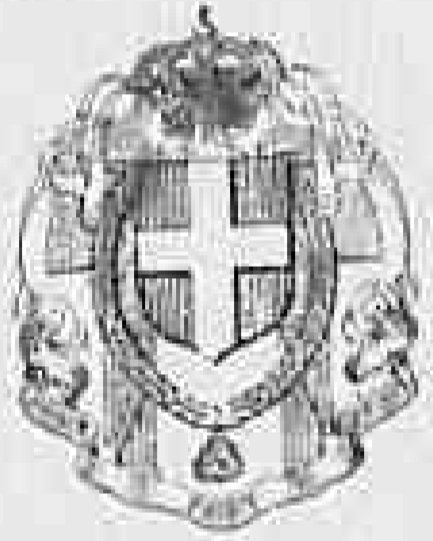



1. The contents of your 208/4 of 20 Nov 44 and the enclosure addressed to the Provincial Commissioners Florence, Pisa, Lucca and Pistoia have been noted.
2. The contents of paragraph 4 of that enclosure appear slightly misleading and may inadvertently confuse the Provincial Commissioners.
3. The delivery to the Prefect of an issue of the Gazzette Ufficiale does not automatically implement the Italian Government legislation therein contained. The legislation contained in a particular Gazette, if not subsequently excluded from implementation, is implemented by a subsequent Gazette containing the official order to that effect and the effective date of operation of a decree contained in the earlier Gazette is the date of receipt by the Prefect of the later Gazette implementing the earlier legislation.

1. Herewith endorsement implementing Legislative Decree of the Lieutenant General No. 247 of 28 Sept 44 in Military Government Territory; for your signature please, *Subject to paragraph 4.*

2. A slight change in the form of the endorsement order was necessary in order to meet the request of the Local Government Sub-Commission which has now withdrawn its previous request and has asked that the above mentioned decree be implemented in Military Government Territory.

3. A copy of the Cassette Ufficiale No. 70 and translation of headings of the decrees contained in said Cassette are also enclosed for your information.

4. It is felt that your attention should be drawn to the fact that this decree provides for the stipulation of electoral lists under R.D.L. 151, of 25 June 1944 which established the Constituent Assembly and which is now interesting Mr. Kirk and the State Department. In these circumstances you may wish to consider whether it is desirable to implement this decree, particularly as this Sub-Commission adheres to the construction of R.D.L. 151 which was previously expressed by the Chief Legal Advisor before he went on leave.

1. Reference is made to your RVIII/19/4000 dated 21 Nov 44 and accompanying letter from PIO Siena Province.

2. The consolidated receipt forwarded and returned herewith is quite useless. This is apparent on reference to the text of the implementation order which clearly states that "the decrees come into force and have the effect of law in each province as of the date on which the Prefect of such Province received a copy of the Cassette containing such decrees".

3. The receipts for the following numbers of the Cassette Ufficiali are missing from Siena Province :-

Nos. 41 - 43 - 44 - 45 - 48 - 50 - 51 - 52 - 53 - 56 - 59 and 64.

So that in any case 41, 43 and 44 are unaccounted for by the PIO.

4. If it is true that the Prefect has not received these issues of the "Cassette Ufficiali" how then can he have date stamped them and distributed them to his provincial officials? Any receipt given under these conditions would be meaningless.

5. Will you, therefore, <sup>please</sup> enquire immediately into this unsatisfactory state of affairs, so that a proper explanation is forthcoming and that any short workings may be adjusted without further delay.

1. The authority previously given to implement Italian legislation in the Army area is hereby extended to cover the delivery to the Prefect of Gazzetta Ufficiale issues Nos. 70 to 80 (inclusive).

2. The copies of these issues now in your possession should be handed over forthwith and the Prefect's receipts forwarded through this Headquarters as previously directed.

3. In respect of future issues of the Gazzetta subsequent to No. 81, no specific authority will be given by this Headquarters and the directions contained in paragraph 5 of letter ref. 200/4 dated 20th October (Florence and Pisa) and 8th November (Lucca and Pistoia) are hereby cancelled.

4. The Italian government legislation to be promulgated in future issues of the Gazzetta will be automatically implemented (subject to the exclusion of any decrees expressly excepted by order endorsed on the Gazzetta) by the delivery to the Prefect of each issue of the Gazzetta as soon as it is received at Provincial Headquarters and without waiting for further authority from this Headquarters. The full procedure laid down in Legal Sub-Commission Directive 400/40 (5/2/4) dated 15th July should be carefully followed on each occasion.

5. The Prefect's Receipt for all issues of the Gazette subsequent to No. 81 will be forwarded direct to the legal sub-Commission and not through this Headquarters as previously directed.

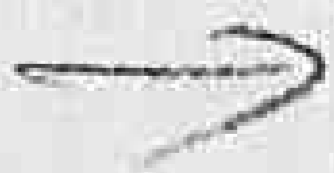

Notes for the V F Civil Affairs Section

Implementation of Italian Legislation in Army Areas.

FIFTH ARMY - A system of periodical implementation en bloc has been introduced in the Provinces of Firenze, Pisa, Pistoia and Lucca. In the two former provinces the Raccolta Ufficiale (blue book) and the subsequent Gazzetta Ufficiale's up to and including No. 61 have already been implemented. The machinery of distribution and prefectural receipts to record effective dates adopted is the same as that in A.L.O. territory.

In regard to the Provinces of Lucca and Pistoia authority has now been given by the 5th Army to the P.C.'s to effect implementation of the Raccolta and G.U.'s up and including No. 69.

The gazettes distributed in Army territory are obtained from the collections held by the S.L.O.'s and, for eventual distribution when such territory intended should pass under Regional Control.

Assuming that the distribution done by 5th Army is really effective and actually reaches the officials and the public, this advance implementation is in line with established policy.

There is really no material difference as far as the work of the Legal sub-commission is concerned.

SIXTH ARMY AREA - Only remaining <sup>area</sup> under Army control is part of the Province of Forlì. Here no steps have been taken to carry out any advance implementation for obvious reasons.

The collection of Gazettes for distribution in this Army area and for the entire Region Emilia has been ready for some time in the hands of the Regional Legal Officer.



NOTES ON D.L.L. 284 EXPEDITING THE PROCEDURE FOR ALLOTMENT OF LAND IN

COLLECTIVE USE TO PEASANTS.

1. D.L.L. 19 October 1944 No. 279 (G.U. 4 Nov 1944 No. 77) sets up a procedure for grant of uncultivated land to peasants.

This decree is being excluded from Military Government Territory.

2. D.L.L. 19 October 1944 No. 284 (G.U. 7 Nov 1944 No. 78) provides for expediting the procedure of allotting land in collective use to peasants.

3. The decree under 1 constitutes an innovation and modification of civil law in that it affects the right of ownership in realty. Such right is made subject to a forced (although only temporary) limitation on the disposal and use of the realty as its possession is given to the peasants holding the grant. This constitutes an extension of the prevailing rules on expropriation for public use and goes beyond the limits of the private law.

4. D.L.L. mentioned above under 2 on the other hand does not affect private property owned by individual owners, (be it physical or juridical persons or public bodies) but it does concern only land "in collective use" i.e. land owned by the state or its subdivisions or in some exceptional cases by private persons which from times immemorial, and particularly from the times of the feudal regime, have been subject to certain "collective rights" such as right of pasture, to cut grass, to gather woods pertaining simultaneously to residents of a certain community.

These rights pertaining to residents of certain communes or "frazioni" of communes as residents not individually but collectively are considered by modern Italian law as a certain type of condominium regulated by public law.

In consequence of the difficulties arising out of the use and abuse of such rights and of the harm caused to the agriculture and forestry (also because of the century long controversies between various communes) the legislator decided to liquidate all such rights (called "usi civici") and to provide for an allotment of the land concerned to peasants in ownership proportionately to the abolished rights and upon payment of certain indemnities. The ascertaining and the liquidation of rights on land in collective use and the allotment of land resulting from such liquidation are entrusted to a "Commissario liquidatore" (usually a councillor of Court of Cassation). <sup>U</sup>

5. The D.L.L. No.284 has the purpose of expediting such allotment, already in progress since 1928. The amendment is in that for the duration of the war and up to one year after the confusion of peace, the said commissioners may authorize that parcels of such land be granted temporarily for use to heads of families in the Commune or "frazione" who assume the obligation to improve the cultivation of the land. These temporary provisions aim to the immediate agricultural utilization of land pending the regular liquidation proceedings. The procedure, of course, shall follow its normal course as set out in the above mentioned laws.

6. In conclusion, the economic and social purposes of two D.L.L. are the same: to further and improve national agriculture according to the necessities arising from the state of war and to ease the conditions of the peasants. However,, the two decrees apply to different sectors and with different systems. The D.L.L. No. 279 affects, even though temporarily the right of ownership. The D.L.L. No. 284 affects rights of collective use, already subjected to special provisions of public law since 1928, when such land was destined to be liquidated and allotted.

3. Commissioner's order.



TO : Regional Legal Officer (THRU: RC) Toscana Region.

1. As agreed in yesterday's telephone conversation (Col. FEBBER- Lt. Col. FRACKMAN) the PLO Arezzo will be instructed at once to take the necessary steps for cancelling the implementation of decrees contained in Gazzetta Ufficiale. As soon as the Province of Arezzo is transferred from the Army to Regional control the process of implementation should be at once repeated with a new effective date being set.
2. It is understood that you will instruct all PLOs that no implementation of Italian legislation will be undertaken before the respective Provinces are brought under Regional control.
3. Furthermore, to obviate any misinterpretation of this Sub-Commission's directive 4010/2/L of 25 July 44 it is pointed out that each PLO receives one copy of Gazzetta Ufficiale for his information. With this copy he receives a memorandum containing the translations of the headings of the laws contained in each issue. The note at the bottom of the memorandum inquiring as to the proposed exclusion from the implementation does not concern PLOs and is expressly directed to Sub-Commissions only. There seemed to be some doubt about this in the mind of the PLO Arezzo.
4. Furthermore each PLO in Provinces under Regional control is receiving packets of Gazzetta Ufficiale for distribution to Italian authorities in his province as stated in the above mentioned directive. Past experience has proved it advantageous to forward the said packets containing previous and current issues of Gazzetta Ufficiale to PLOs or to RLOs for their PLOs before their province is handed over by the Army to the Regional administration so as to enable the PLOs to proceed with the distribution to Italian authorities immediately after the transfer of the province to Regional control. For this reason all PLOs of your region with the exception of PLOs of Massa, Lucca and Pistoia have received the packets containing past issues of the Gazzetta Ufficiale (including the reprint of the Brindisi-Salerno legislation) and are receiving the packets with the current issues. It is intended to include the above enumerated 3 PLOs in this scheme within about eight days with the under-

standing that none of the PIOs within the Army area will proceed with the distribution at this date.

5. Contrary to what is stated in para 6 of the aforesaid directive all three copies of receipts for G.U. were in many instances forwarded to this Sub-Commission. Kindly call this para to the special attention of PIOs.
