1. Reference your 6 Sept. 1945 LB/53/113 and attached correspondence.

2. The cases listed in attached schedule are not in the files of this Sub-Commission. They were evidently tried in Italian Courts.

3. Unless the cases were properly brought to this Sub-Commission we would be without jurisdiction to make any order concerning the monies.

4. Reference para 4 of attached letter A.38/5 articles 11 and 28 Consolidated Instructions provide that property or money seized must be produced in court and the court must scrutinize closely, reasons for its non production. The court must enter a proper order for its disposition.

5. Art. 28, Sect. 3 Par "e" provides that "Confiscated money will be paid to nearest Provincial Finance Officer."

6. Unless these cases contain a proper order of either an Italian or AMG Court as to the disposition of these monies, they will have to be returned to the accused.

SUBJECT : Disposition of Forfeited Goods.
TO : Provincial Commissioner LIVORNO Commune, (Attn: Senior Legal Officer).
1. Reference letter of TO C.M. Berdon RYTH/19A of 29 June 1945.

2. In the cases referred to, forfeiture of the goods was ordered under the general powers of the Courts by reason of the wrongful use, sale, purchase or possession of the property in question (see Proclamation I, Article VI). Under Article 26 paragraph 3, c, Consolidated Instructions confiscated unperishable goods will be at the disposition of the Provincial Commissioner. It is proper for the Regional Commissioner to direct that this property be turned over to the Prefect, Florence Province, to be disposed of by him in his capacity as such, and in accordance with the lawful powers vested in him as such officer.



TO : Public Safety Sub-Commission
(Attn: Col DOWERTHY).

1. In answer to your oral request we have to advise you that we have been unable to discover any directives dealing with the disposition of the possessions which may be found on enemy agents.
2. The property of a person arrested on suspicion of espionage should be treated as that of a person arrested on any other charge, e.g. murder. The prisoner retains possession of his property subject to custodial or security exigencies. Such property as may be removed from his possession must be held subject to any order the Court may make; or, in the event there is no such order, must be returned to the prisoner upon his discharge.
3. If the alleged enemy agent is ultimately convicted, the trial court should be asked at the conclusion of the trial to make an order of confiscation with respect to such property as may properly be said to be an integral part of the mission of espionage. Such property could include for instance, a radio transmitter, or photographic equipment. It would not include personal clothing. Money could be made the subject of a confiscation order depending on whether the facts of the case showed it to be connected with the mission of the accused.
4. The strict legal position is in the event of the execution of an enemy agent, that such property as is not confiscated, is held by an appropriate public official for the benefit of his executor or legal representative.

AAI, CHP.Reference your And/36/10 Petrelli v/1 (AJM), dated 12
Oct. 44.1. According to Italian law the sale of the olive oil
by the civilian to the Italian soldier was illegal and
constituted an offence by both the seller and the buyer.2. Furthermore the unauthorized transportation of the
oil from one district to another may be illegal under Italian
law, if the competent prefect has issued an order prohibiting
it.3. According Art. 240 Italian Penal Code, confiscation
shall always be ordered of articles whose manufacture, use,
carriage, possession or sale constitutes an offence, even
though a conviction has not been pronounced.4. The confiscation entails the loss of any private
ownership.The confiscated articles devolve upon the state.
olive oil, by virtue of special provisions in this matter,
shall be delivered to the "ammasso".

Olive Oil - Confiscation - Ownership

1. Lt-col D.D. Carrick, the AJAC of this HQ, today spoke to Dr. Forti about a legal problem which has arisen in this HQ, involving Italian Law, and it was arranged that this letter would be sent to you in order to obtain your written confirmation of the verbal opinion on Italian Law given over the telephone.
2. A Canadian soldier stationed at Avellino purchased from a civilian, on 26 July 1944, a quantity of olive oil, the purchase taking place somewhere south of Cosenza - the exact location not being known. The civilian was paid and the olive oil transported by the Canadian soldier back to Avellino, where his possession of the olive oil was discovered. The soldier was tried by a Canadian Court Martial, convicted and given two years' imprisonment for an offence against Military Law in connection with the illegal use of a Canadian military vehicle.
3. The olive oil is being held by the Canadian Provost at Avellino and this HQ has been asked for an opinion as to what disposition should be made of the olive oil.
4. The matter is being considered from the point of view of Canadian Military Law and it is desired to have your opinion on the legality of the sale under Italian Law and on the ownership of the oil.
5. Lt-col Carrick was advised as follows:
 - (a) Under Italian Law the sale was illegal and an offence by the civilian against Italian Law.
 - (b) The oil in question, as a result of the illegal sale, is subject to confiscation and deposited in the ammussi. No ownership of the oil passed to the Canadian soldier as a result of the sale.
6. Your opinion is also requested on whether the transportation of the oil, under Italian Law, was illegal and, if so, whether the oil was thereby rendered subject to confiscation, and the effect of such law on the ownership of the oil.



SUBJECT: Disposal of Property of Arrested Civilians.

TO : All Addressees.

1. Report has been received from the Allied Control Commission that in numerous cases, military arresting authorities have improperly disposed of firearms and other personal property taken from arrested civilians. This irregularity may prevent the production of the necessary evidence in court and thus impede administration of the law.

2. It is desired that commanders of arresting authorities issue the necessary instructions to assure that all property taken from arrested civilians is properly secured and held available and subject to the disposition and decisions of the Allied Military Courts. Property which belongs to any of the Allied Military Forces should be held by the arresting authorities sufficiently long to be produced as evidence before the court and then returned directly to the owning force by the arresting authority.

SUBJECT : Property of Arrested Persons.

1. There have arisen a number of complaints in several regions of the Military Police, officers and enlisted men, of disposing of firearms and other property seized at the time of arrest of civilians who are charged with offences to be tried by Allied Government Courts. At the time of trial such property has often disappeared and cannot be produced at the trial of the accused. This failure to produce such evidence often prevents the Court from arriving at a proper adjudication of the case.
2. It is requested that you issue an order to the Military Police, and all other military personnel concerned, requiring all property of arrested civilians be held for disposition of the Allied Military Courts and subject to disposition in accordance with decision of these courts.

involved for the disposition of the Allied Military Court and dispose of it in
accordance with the decision of that Court.



1. Region III reports considerable difficulty with the Military Police over the disposition of property taken from arrested Italian civilians. For instance pistols taken from civilians are kept by the arresting military personnel. The same is true of trucks as well as other articles. Property is reported as being disposed of by the Military Police, officers and enlisted men, as if they had the right of complete disposition even to the extent of doing so for their own personal benefit. This ousts the Military Courts of their jurisdiction to dispose of the property and makes it unavailable as evidence in cases.

2. There must be some clear line of demarcation between the functions of the Allied Military Government and the P.B.S. + 57th Area with respect to the civilians. Region III R.L.O. believes that orders should be issued to all military personnel and especially to C.I.D., F.S.S. and Military Police that property which is seized on the arrest of a civilian and involved in the offense must be held for the disposition of the Military Court and must not be disposed of by any other authority.

1. With reference to the memorandum (283/30/CA) of 28th February, it appears that on some occasions when arrests have been made by Military Police, property which is subject of the charge or other property in the possession of an accused person has not been handed in to the Court.

2. The position would be regularised if orders were issued by the Commander-in-Chief providing that:-

(i) When Military Police make an arrest of any Italian person, all property the subject of the charge and all property in possession of the arrested person shall be handed into the custody of the Allied Military Court hearing the case.

(ii) That in any case in which goods in the possession of an arrested person are sold, the proceeds shall also be handed into the Court and

(iii) That any Order made by the Court as to the disposal of such property shall be final unless reviewed in accordance with the provisions of Proclamation No. 4 (as amended).

3. It appears desirable that the matter should be dealt with in connection with the proposed new directive and it is requested that the matter may be taken up with the appropriate authorities.

1. It is understood that cases have occurred in other Regions which indicate the need for precise directions to be issued as to the disposal of property which is taken into custody by A.M.G. courts as evidence at a trial.
2. It is considered that disposal should always be exercised under a written order of the Court at which the case is tried, except in the exceptional case where perishable goods are involved and a direction from the court cannot be obtained without delay, in which case, it is thought that any Provincial Commissioner, Provincial Public Safety Officer or Provincial Officer should be empowered to order disposal subject to a copy of his order being lodged with the Court before which the case is tried.
3. It is requested that consideration should be given to the issue of a general directive in the matter.
4. If the proposal is agreed to, it is intended to issue instructions in Region 4 as to the detailed procedure to be followed to ensure inter alia that:
 - I i) Military stores are returned to depots which can take them on charge.
 - ii) Civilian supplies do not find their way into the black market and
 - iii) The proceeds of sale are properly accounted for.
