1. It is respectfully requested that the name of the a/m substitute Procuratore Generale of the Court of Cassation, who is presently employed as Procuratore del Re of the Tribunale of Naples, be submitted to the Minister of Grace and Justice, with the recommendation that he be promoted to Procuratore Generale of a Court of Appeal (remaining actually in his present post of Procuratore del Re).

2. SIRACUSA Gr.Uff. Francesco, is a senior magistrate, having been promoted to his present grade after a concourse made seven years ago at which he achieved 8th place in a list of 250 candidates.

3. It is noted that somewhat similar action has been taken by the Minister in the case of two Presidents of sections of the Court of Appeal of Naples, who have been appointed as First Presidents of Courts of Appeal while retaining their actual functions in the inferior positions.
