The Commandatore cannot under existing law be promoted to be 3rd grade Procuratore Generale at Bari Court of Appeal, since he has not yet completed even one of the minimum three years in the 4th grade. But it is urgently desired for him to replace the supine di Santis. It would be a very great loss to the administration of justice in Apulia if Commendatore Vita were to be transferred to Rome as in him alone of the civilian magistrates have we found all the elements necessary for collaboration. In the first place, he understands that in the higher interests of Italy Italian law must be so applied as adequately to protect allied troops and material and that this requires alteration of administrative practice and occasionally a modification of what appears the primary interpretation of the law, and in the second place he has the necessary elasticity of mind, authority, technical skill and bodily activity to see that this is done.

3. In the Lecce section of the Court of Appeal District directed by him, though it could be improved, gives no reason for complaint. In the remainder of the district we have found many causes for complaint. 7. For this purpose I respectfully submit a visit of Region 2 officer to Salerno is essential. In any case it is of the very highest importance that the Ministry should not know that Comm. Vita has been consulted. For this reason I have marked the letter confidential.

Hannaford, advance party of this Subcommittee now in Rome, have specifically requested that H.E. Casati go to Rome as quickly as possible.

(b) Dott. CIULLI Danilo - Liaison officer between Legal Subcommittee and Minister of Justice. Born at Penne (Pescara) 30-9-1911. Identification Card U.P.U.C.I. No. 6205 (Italian Consul General, London). The above two ACC officers have likewise requested the presence of Dott. Ciulli in Rome where because of his wide knowledge of affairs (he is a resident of Rome) he would be of invaluable assistance to them particularly in these early stages.

TO : H. E. Minister of Justice.

1. A preliminary report on the above from the Provincial Legal Officer shows the urgent need for the appointment of at least four additional judges experienced in criminal law to reinforce the judicial personnel of the Tribunale, and to enable three sections to sit daily. Moreover, it is stressed that in regard to the work of the Preture, those of Nocera, Eboli and Laviano have an insufficient number of magistrates to work these courts.
2. The report also refers to the inadequacy of proper accommodation, and to the lack of office supplies and equipment, all of which it is hoped may be remedied in the near future as premises become derequisitioned and supplies of materials released.
3. In view of the fact that recent developments have considerably relieved the situation generally in regard to scarcity of judicial personnel, it is hoped that your Excellency will be able to proceed immediately to the nomination of suitable magistrates to make up the complement of judges necessary for properly carrying out the business of both Tribunale and Preture in this district.
