1. With further reference to para 1 of your letter AC/4039/L dated 4 Nov. '44 I have now been informed by P.L.O. Ancona that the matter of Rabini's appointment was discussed by him with the Procuratore Generale and that the latter in fact recommended the appointment as he considered Rabini the man best qualified for the position.

2. When this temporary appointment was made Ancona Province was under the jurisdiction of 8th Army and P.L.O. Ancona states that in his opinion it was important and necessary that the appointment be made immediately. Accordingly the provisions of para 1 B of your Directive ACQ/4039/L dated 3 May '44 were invoked.

3. I have pointed out to P.L.O.s that as no part of this Region is now under Army Control the necessity for invoking para 1 B of the Directive above quoted should arise only in very exceptional cases in the future.

1. Reference is made to your letter Acc/4039/L of 10 Sept. 1944. addressed to SCAC., HQ, AMG, 5 Army.
2. The A/M magistrate was first arrested on security grounds by I.C.U. and was later released under house arrest.
3. He has subsequently been re-arrested on 5 October 1944 by 427 A.S. Section, with the recommendation of the P.S.O. that he be interned for the duration of the war.
4. Reason for arrest as supplied by O.C. 427 A.S. Section is as follows:

"Enthusiastic pro-German and pro-Fascist (Source-Comitato Toscano di Liberazione). As Procuratore Generale of the Court of Appeal was influenced in favour of Fascists, e.g. when, during the German occupation, a P.R. political secretary was arrested and charged with murder, he allowed his release on the grounds of 'the moral qualities and position held by the arrested man.' Took extreme measures to obtain the punishment of prison officials responsible for the escape of 16 anti-Fascists arrested under the Republican regime."

A few persons are in Gaol awaiting trial for proclamation offenses. The cases are still under investigation. - (d) No cases have been heard by the Court of Assize of Aquila because the Vice Minister of Justice in a visit to Aquila on 5 Oct. stated that the law regarding Popular Judges was being amended. He promised information within 8 days. None was forthcoming from him, but particulars were given on 22 Oct. by the Legal Sub-Commission. It is understood that the procedure must be implemented by a Decree the publication of which is expected at any moment.
- (e) The Sostituto Procuratore del Regno at Aquila, Dott. TRADAKDI Mario, left his post on 29 Sept. without permission, and was accordingly suspended by AMG on 14 Oct., and two temporary assistant recommended by the Procuratore Generale and the Procuratore del Regno were appointed in his place.

2. The reference to the decree in para (d) above was written before the "Gazzetta" containing the decree was received.
