Subject: Case of PAULI Raffaele-Maresciallo, and  
GIULIO Salom.

To : Regional Legal Officer Region IV.

1. Capt GIULIO SALOM accompanied by Maresciallo del Carabinieri Reali PAULI left base for ORVIETO on 27th July, with the duty of looking into the question of recovering Italian military vehicles.

In doing so he was acting on orders of his Admiral, in concert with Naval Sub-Commission, BR ACC.

2. In the course of his journey they had a "discussion" with an American Lieutenant PAOLINO Virgilio and a subsequent interview with Major BAKER of ORVIETO.

3. As a result, they were served with a charge sheet and ordered to appear before an Allied Military Court at ORVIETO on 3rd August.

4. The charge sheets are obviously bad for want of particulars in that the charge reads as follows:-

"First charges: Proc I; Art IV, Sec 11; Art V, Sec 31, 39, 42, 45."

There are no particulars: the accused do not know what property of the Allied Forces they are supposed to have destroyed, damaged...stolen...or been wrongfully in possession of; what words hostile or disrespectful to whom they are alleged to have uttered; what false statement they are alleged to have made to whom; what order they are alleged to have disobeyed; what act to the prejudice of good order...or of the safety or security of the Allied Forces they are supposed to have committed. It is obvious that the proceedings cannot be permitted to go to trial in this condition.

5. Further, attention is directed to the Consolidated Instructions for Allied Military Courts Art 4: which lays it down that "in the absence of some very special reason to the contrary, the jurisdiction (to try members of the Italian armed forces) will NOT be exercised....in case of doubt...the case should be referred to the CIG, H.Q. ACC for his instructions."

6. From a report in possession of the writer of this letter, this certainly is a case of doubt. It is therefore directed that the proceedings on 3rd August be adjourned and that the case be submitted to the Chief Legal Officer for his instructions, with a full report of the facts alleged against both accused and with proper particulars of the charges made against both accused.

7. The accused will attend the Court on 3rd August: they will be accompanied by a member of the Staff of Commodore PALMER, Director of the Navy Sub-Commission who will be furnished with a copy of this letter.

SUBJECT : Review of Sentences of A.M. Courts - Army Areas.

TO : G.S.O., Administrative Section.

1. In army areas so long as S.L.Os were present they performed review functions in connection with A.M. Court cases.

2. As the S.L.Os will be withdrawn as of August 1 it would seem natural that the reviews should henceforth be under the charge of the RLO of the particular region <sup>in which</sup> of the particular army area under which they will fall. However, it appears that the two armies have put a strict embargo against the communications between specialists at Regional HQ and the specialists in army areas.

If this was strictly adhered to the review of Allied Military Court cases could not take place and it is necessary that the reviews be promptly made. I therefore suggest that at the meeting on Wednesday at HQ, AAI, you discuss this matter and request that legal officers in army areas be permitted to send to the RLOs of the particular regions into which the particular territory will fall cases for review as if, for this purpose only, the particular army area was already under Regional control.

Here in Rome the Allied General Court has just pronounced a verdict in the first trial it has held in this city. The court condemned a young Italian Communist partisan to 18 months imprisonment. He was Rosario Bentivegna. He was one of the most active partisans in Rome during the German occupation. On June 5 just a few hours after we entered Rome and the streets were still being patrolled by Italian partisans Bentivegna shot and killed a Lieut. of the Italian Customs guard during a street altercation. The defence claims he acted in self-defense. The prosecution claimed he acted impulsively in legitimate defence. But that was not the main issue of this trial. The main issue was much larger. We the Allies, are urging the Italian partisans to create confusion and disorder behind the German lines, and we impose standards of peace-time law and order upon them.... This is what the Allied prosecutor during the trial said: "We must not forget that the purpose of this court is that of safeguarding public order.... Americans and Englishmen have come to this country to teach liberty to the Italian people.... This court must keep order and must give some examples of which Italians have a great need"....

The reaction of the Communist party to this verdict is very bitter. The party paper this morning says that while Bentivegna is condemned two of Fascism's worst figures.... the former chief of Police in Rome and the General who surrendered Naples to the Germans are still living. The paper says this verdict will be heard with apprehension by all democrats and fighters of the United Nations who believe that the defence of liberty and order is essentially Italian resistance to the death against Fascism." After this verdict it will be hard for Italian patriots to decide whether the Allies have come to Italy to destroy Fascism or to impose order.

Major Hendrickson, AMG chief legal officer, Rome Region, has asked the Allied Publication Board to consider action against the Italian Communist paper "Unità" which criticised the AMG court verdict on Bentivegna. The paper criticised the Allies for their delay in trying Caruso, former Rome police chief, and compares this with the trial of Bentivegna who for 9 months risked his life fighting for the Allies. The Court said that this was a case of two excitable young men who lost their tempers and used firearms unnecessarily. The Court could not accept self defence as a plea and could not agree that it was necessary to use the amount of force the accused had done.

Weiszacker, the German Ambassador to the Vatican, has given us as his private opinion that all overtures between the Pope and the Allies would be doomed to failure unless direct approaches can be made between the Vatican and Russia.



1. I enclose a petition (with translation) relating to proceedings against three brothers CASTALDO Luigi, Armando and Mario.

2. These proceedings were recently reviewed: the papers were read with great care by Capt. MORE and the review was actually signed by you. I do not remember the details of the case: I remember it was a question of driving a truck down to a grain producing area to bring back food stuff to Naples area: but I think Capt. MORE will be able to tell you more about it.

3. This petition raises a point entirely new to me. The mother of the three accused now alleges that, at her instigation, her son Mario deliberately gave false evidence which had the effecting of shifting part of the responsibility onto him, whereas he was entirely innocent.

I confess that I find the story improbable. In particular, I do not understand this business of spontaneously presenting himself: either he was charged or not. I suspect that it is a new "line" to get at least one son out of prison.

4. There are 3 courses open:-

- (a) To believe the petition and release MARIO-I advise most strongly against this !!
- (b) To disregard the petition: but then an innocent man (through his own fault) may spend 2 years in prison.
- (c) To order a new trial before a strong Superior Court and to direct the prosecution to consider the addition of a charge of perjury against MARIO and such of his brothers as testified as to his complicity.

This may have the effect of putting them away for more than 2 years.

5. May I please either be told what action you wish taken or be kept informed of whatever action you may take. 28

1. I enclose a petition (with translation) relating to proceedings against three brothers CASTALDO Luigi, Armando and Mario.

2. These proceedings were recently reviewed: the papers were read with great care by Capt. MORE and the review was actually signed by you. I do not remember the details of the cases: I remember it was a question of driving a truck down to a grain producing area to bring back food stuff to Naples area: but I think Capt. MORE will be able to tell you more about it.

3. This petition raises a point entirely new to me. The mother of the three accused now alleges that, at her instigation, her son Mario deliberately gave false evidence which had the effecting of shifting part of the responsibility onto him, whereas he was entirely innocent.

I confess that I find the story improbable. In particular, I do not understand this business of spontaneously presenting himself: either he was charged or not. I suspect that it is a new "line" to get at least one son out of prison.

4. There are 3 courses open:-

- (a) To believe the petition and release MARIO-I advise most strongly against this!!
- (b) To disregard the petition: but then an innocent man (through his own fault) may spend 2 years in prison.
- (c) To order a new trial before a strong Superior Court and to direct the prosecution to consider the addition of a charge of perjury against MARIO and each of his brothers as testified as to his complicity.

This may have the effect of putting them away for more than 2 years.

5. May I please either be told what action you wish taken or be kept informed of whatever action you may take.

1. Reference is to your letter ACC/4083/23/L of 25 June 44 on this subject.

2. I personally had no knowledge of the granting of this pardon. I have, however, consulted the former Regional Legal Officer who informs me -

a. that he had no knowledge that pressure had been brought to bear on the Legal Sub-Commission or even that they were concerned in the matter at all;

b. that the only information before him when he considered the application was that contained in the papers which you have already seen; and

c. that his reason for advising the then Regional Commissioner to grant the pardon was that he considered it the proper thing to do in the circumstances of this particular case.

3. While it is appreciated that any action taken by the Allied Military Government may be cited as a precedent by anyone who wishes similar action to be taken, it is considered that the granting of any act of clemency is based on factors so numerous and varied that it could never properly be regarded as establishing a precedent. 13

4. You may rest assured that the discretion given to the Regional Commissioner to pardon offenders has been, and will continue to be, exercised very sparingly.

5. It would appear to be desirable to avoid, in the future, the state of affairs which has arisen in the SALERNO case. It is therefore suggested that where an application for a pardon is received at this headquarters relating to a case which has been or will be reviewed by you, the application should (as happens at present) be forwarded to you with such comments as the Regional Commissioner may care to add, and that, conversely, applications received by Headquarters, ACC, concerning cases reviewed by or on behalf of the Regional Commissioner should be referred to this headquarters, with comment if desired, for disposal. This seems to comply with the intention of Article 33 of the Consolidated Instructions.

1. Ref letter 325/10/CA of 1 Jun 44, received through Region V, this matter has now been investigated.
2. It is true that on or about 15 Mar 44, a PS Sgt of 5 Corps made the arrangements mentioned in PIZZOPARTO.
3. At that time the place was in 'no man's land' and frequently visited by enemy patrols.
4. Communication with the commune was only possible on foot, from VILLA SANTA MARIA, involving a four-hour journey.
5. PS personnel were taking up ammunition for certain Italian individuals in the village.
6. The road to VILLA SANTA MARIA had not then been opened and the CAO of the area was located at COLNABUZZO.
7. The PS personnel were asked by the CAO to carry out the arrangements mentioned, and in the difficult and unusual circumstances prevailing his action is fully approved.
8. It was possible to put into VILLA SANTA MARIA early in April a CAO who visited PIZZOPARTO and other communes, although the same difficulties in the matter of communication existed.

1. Your attention is drawn to the sentence in the case PICCILLO Aniello, 10,000 lire (or 6 months) and "5 years imprisonment the last 4 1/2 years suspended during good behaviour for 5 years."
2. There are too many suspended sentences being given. The grounds upon which such sentences are to be given are set out in Consolidated Instructions for Allied Military Courts Art. 26, para 3 (d); and attention is also drawn to ibid (e) which provides "the reason for the suspension will be noted on the record."
3. The same paragraph also provides that a suspended sentence remains in suspense during the continuance of Allied Military Government; therefore it is not necessary to suspend a sentence or part of a sentence "during good behaviour for 5 years"; it is hoped, moreover, that Allied Military Government in NAPLES will have come to an end before 25th May 1949.
