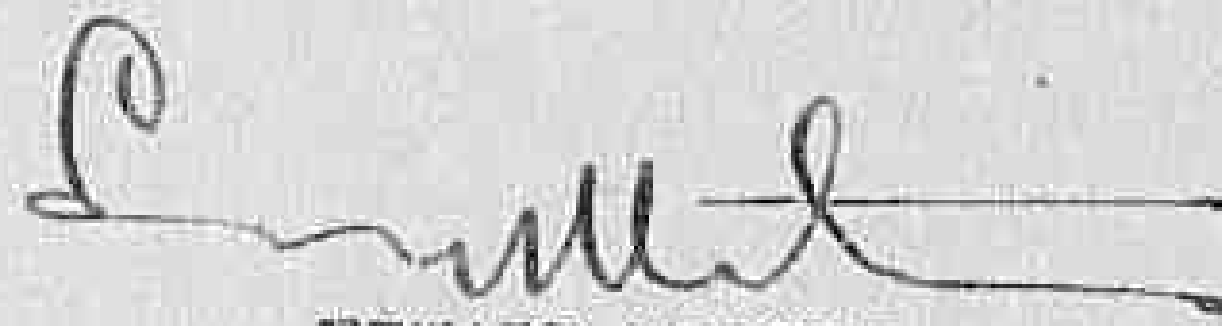

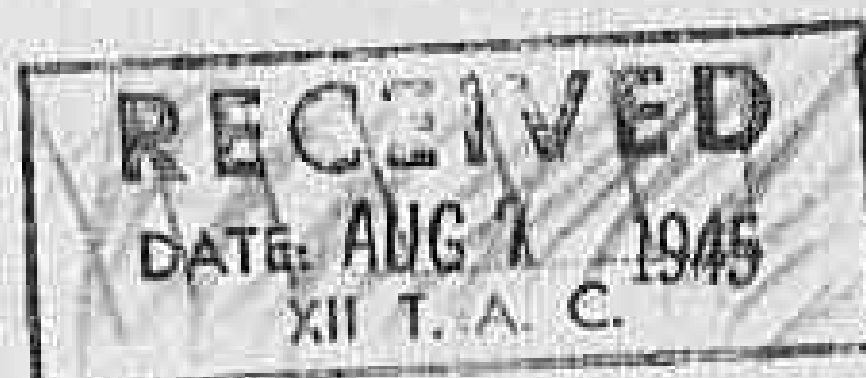
Reference your letter 1 June 1945.

1. According to my best recollection, there was only one case in which the property involved came directly into the custody of the Regional Legal Officer. In that instance I had treated with the dispositions of the property in my decision on review and the property which consisted of certain photographic equipment was then in the possession of the U.S. Military Police.
2. As result of my remarks the property in question was subsequently delivered to the Central Prosecutor's Office in the Palace of Justice and subsequently delivered to my office, where it was deposited in a safe, pending delivery to its proper owner.
3. As I recollect now, the property was in my safe for quite some time before it was claimed by its owner. Thus I am unable to say exactly when it was delivered, but as to this one thing I have definite recollection, namely that specific instructions were given in respect of the formalities which should attend the identification of the owner and the delivery of the property.
4. As to the delivery itself, it is my impression that it was made either by Capt. Graziano, my Deputy, or Pfc. Scorpiniti, my chief clerk, and it runs in my mind that Major Coxhead was present, representing the Public Safety Division.
5. It may be that more specific information can be furnished by Mrs. Mary Leslie, who at that time was serving as my personal secretary and is now employed at the British Embassy in Rome. On one point I am quite certain, and that is that formal receipts were taken at the time the property was delivered. These should be in the Lazio Umbria Regional Legal Files.

6. Since there was only one instance in which property came to the Regional Legal Officer, there is every reason to believe that it is the same property referred to in your letter of 1 June.

7. In conclusion I suggest that you communicate with Capt. Graziano and Pfc. Scarpiniti, for I am convinced that between them they will be able to furnish all the facts you require. From my point of view I am convinced that the camera which was in our possession was properly delivered and to its rightful owner.

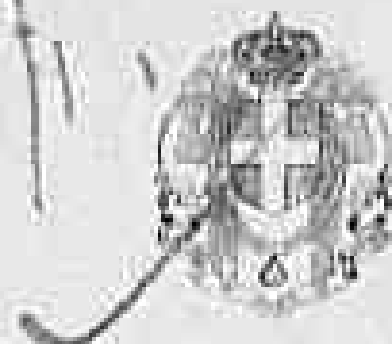
With reference to your note of 1st August, enclosing copy of your letter of 3rd June, this Sub-Commission understands the position to be as follows :-

- (a) MMIA Administrative Order No. 13 was never meant to exclude the jurisdiction of AMG Courts over Italian military personnel. It simply made it clear that although for all other administrative purposes Italian military personnel fall under Allied military administration, the Italian Military Courts were still competent to try them for criminal offenses.
- (b) Insofar as Italian Government Territory is concerned RUL 31 of 11 Feb 44 and more so RUL 112 of 13 April 44 (Art. 1) make it abundantly clear that AMG Courts retain full jurisdiction over Italian citizens, whether military personnel or not, who commit an offence against Allied interests.
- (c) As you are aware, these decrees, passed at the request of the Allied authorities, and forming part of the terms of restoration of territory to Italian administration, can only be abrogated, amended or modified by subsequent legislation approved by Allied authorities and not by administrative order.
- (d) It is obvious that the rights of the Allied Courts are not less in AMG territory than in restored territory, indeed under the Laws and Usages of War on Land (Art. 49) and accepted international practice they clearly have full jurisdiction to try Italian citizens.
- (e) Furthermore so far as concerns sentences which have actually been passed by AMG Courts on Italian military personnel in AMG territory you will remember that by Art. 2 of RUL 31 such sentences are recognized as valid without restriction.

In regard to the matter of business you made inquiry about in your letter, the appointment of Avv. Emilio Cannarella of Pisa as Military Judge of Surveillance of Pisa in November 1944, the facts are these:

1. When Pisa was liberated we found that the job of surveilling the prisoners at the prison in Volterra and the inmates of the Volterra Psychopathic Hospital had been neglected for many months.
2. In order to prevent unrest and possible rioting in the prison and the hospital, on the recommendation of the President of the Tribunale of Pisa, the Provincial Commissioner temporarily appointed the President of the Tribunale as Civilian Surveilling Judge.
3. President Cangini of the Tribunale in the above mentioned capacity worked diligently and conducted between 200 and 300 hearings at the hospital and the prison, thereby removing the possibility of riots at these two institutions from civilians.
4. President Cangini had no jurisdiction over the military prisoners and inmates of the two institutions, however, and very shortly there was a possibility of trouble from this group who had not been surveilled and believed themselves to have been discriminated against.
5. On my recommendation, as well as President Cangini's, the Provincial Commissioner of Pisa appointed Avv. Cannarella to the temporary position of Military Surveilling Judge to cope with this situation. I am not certain of the date but the appointment was in writing.
6. Avv. Cannarella was appointed because he was the only man available with a military judicial background and the emergency

then existing required action.

7. He was instructed to submit a budget which was checked with the Italian military district when it was established in the Province later. I discussed payment of Cannarella later with the Provincial Finance Officer and thought that provision had been made to pay him.

8. I can certify that there existed an emergency at the time which required his appointment by the Provincial Commissioner.

Mr. Colonel WEBER,

The undersigned Adv. CANNARELLA Emilio, living in Pisa, Via S. Andrea No. 19, respectfully exposes as follows:

On November 26th 1944 I was appointed by the Legal Officer of the AMG of Pisa as Military Judge of Surveillance for the Province of Pisa. Because of this appointment, I have acted near the Prisons of Pisa and near the Lunatic Asylum of Volterra. The Legal Office did not establish any monthly pay. However since my rank in the Italian Army was of Captain of Infantry, it was understood that I should be reward-ed with an equipolient payment, encreased with the present wages of embetterment.

For my duties I was obliged to make arrear payments up to Lire 1715, as it is testified by a voucher that I delivered to Lt. E.E. NEVANS.

Now, as my appointment has been revoked by the Military General Prosecuting Officer of Florence, I have ceased my activity since the 5th July 1945.

Although I have asked the payment of my work since the first times of my duties, I have not been rewarded so far.

I only received \$ 160 by the Local Prefectura thru the Finance Division of AMG Pisa.

I have been many times to the Legal Office of the AMG in Pisa, but I have been told there that I should contact the Ministry of Grace and Justice, or the Ministry of War, from which I streightly depend. But I know that a claim of mine filed to those Bodies will remain without any answer, until an Allied Organization will not certify my appointment. Indeed I haven't been appointed by an Italian Authority, but just by an Allied Headquarters. So they can't arrange anything for a payment of my work, unless you order to them to do so. 78

I am coming therefore to beg you to want to interest for my payment: either to dispose for a proportionate reward directly from the Legal S/C or to stress to the Italian Authority the duty to provide for a proper arrangement.

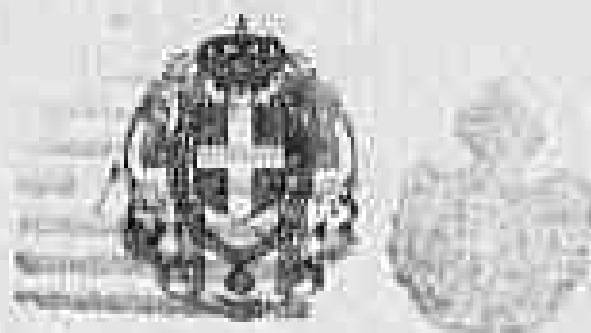

1. This office recently received information alleging that an American soldier was murdered in the Montesanto Section of Naples about one year ago. An examination of the American police records in Naples, revealed that an incident of a knife assault of two American soldiers by Italian civilians, resulting in severe wounds and the hospitalization of one of the soldiers occurred on 5 Sept. 1944 in the above named section. The case was reported to the CID Office and turned over to the SIS, agency in Naples for investigation. This latter agency is unable to locate the case in their files.

2. A check of the prosecutor's office revealed that the above case of assault, Case No. 11646 and 11647 was tried in superior Court in Naples on 25 Sept. 1944 and the two defendants, Borelli Giuseppe di Raffaele and Mazzola Giuseppe fu Francesco were found "Not Guilty".

3. The arresting officer in this particular case was Pfc. Joseph W. KUCZEK ASN. 32714645. Co.A, 803 M.P. Bn. APO 782, and one of the witnesses was S/Sgt. Williard DREVINS, 601 F.A. Battery A. APO 285.

4. In view of the information this office has received, we are desirous of obtaining a copy of the Courts proceedings on this case, inasmuch as it may contain information regarding the soldier that was wounded, and now allegedly murdered.

5. An immediate consideration of this request will be appreciated.
