SUBJECT : Confiscation of Goods by AMG Courts.

TO : Regional Commissioner, (Attn: Regional Legal Officer), Umbria-Marche Region.

1. In reply to your RS/511/14/AMC of 30 March 1945. It is to be noted that this RS letter to which you refer does not apply to confiscation in all "black market" cases; but only to confiscation of vehicles. The statement that confiscation of a vehicle should only be ordered in "very exceptional cases" is intended to discourage the making of such confiscation orders except in those rare cases when the judge considers that justice cannot otherwise be achieved.

2. Article 27 of Consolidated Instructions provides that normally confiscation will not be ordered unless the wrongful use or possession of an article is the substance of, as opposed to incidental to, the charge. Such an order would therefore be "exceptional". In cases where the value of the article concerned is entirely disproportionate to any thing else in the case, including the jurisdiction of the court, such an order should be "very exceptional".

3. In cases where a person is charged with traveling without a permit, or buying or exporting goods without a permit, the use of the vehicle is incidental to the charge, since in most cases the actual offence would not be committed without the use of the vehicle. As a general rule, moreover, it is perfectly adequate to impose an adequate punishment by fine or imprisonment or both without the necessity for the additional punishment of confiscation with all the disadvantages previously explained. 120

4. Cases do occur, however, where the normal punishment would not achieve the results desired by the court. Examples, which are not intended to be exhaustive, are:-

the repeated use of a vehicle for purposes of this nature;
the impracticability of sending the accused to prison;
the particular gravity of an individual offence;
the necessity for punishing the owner (as opposed to the driver) of the vehicle.

5. It should perhaps be added that a local shortage of transport is not a "very exceptional case" either for this, or any other purpose.

6. The last part of your letter, I think, must be based on a misreading of our letter: it does not prohibit confiscation by a summary court; on the contrary it states expressly:

"It is permissible for such an officer" (i.e. a non-legal summary court officer; and a fortiori, the same must apply to a legal officer) "to award a sentence within the jurisdiction of a summary court and to make an order of confiscation."

The above quoted passage is in accordance with Consolidated Instructions Article 27 (4) which provides that the power of forfeiture is additional to other powers but that officers sitting in Summary Courts will not make use of the power merely to impose a penalty which will, in fact, exceed 50,000 lire.

The two cases dealt with in this HQ letter of 13 March were both heard before a Summary Court in one case the court consisted of a legal officer and in the other of a non-legal officer. It is thought that both these courts used their power to order forfeiture in such a way as to impose a financial penalty which they could not, and probably would not, do by fine.

Nothing in that letter is intended to depart from the principle laid down in Consolidated Instructions Article 27; but cases where an article worth many millions of lire may be confiscated should be heard by a Superior Court.



Reference your letter of 27 Feb. 45 subject "LATTABULO Vito Vincenzo."

1. LATTABULO Vito Vincenzo was tried on various charges. The record was reviewed with great care by more than one officer at this HQ. As a result, the conviction on one charge was quashed and other orders were made, including the reduction of the term of imprisonment to be served.

2. At a later date, LATTABULO addressed a communication to the Chief Commissioner. The Legal Sub-Commission then reconsidered the case and was of opinion that LATTABULO was properly convicted.

3. The case is res judicata; no machinery exists for re-opening the case; moreover, the reduced term has been served and therefore no useful purpose can be served by giving the case any further consideration.

4. It is observed that you ask this Commission to take action. As the petition is addressed to Lt. General Mark W. Clark by name it is thought that the answer, if any, should be from his HQ. If it is decided to answer LATTABULO, it is suggested that the answer should be limited to a formal reply stating that it is not proposed to comply with the request contained in his letter.

SUBJECT : Informal Petitions.

TO : H.E. The Minister of Grace and Justice.

1. As your Excellency is, no doubt, aware a person convicted by an Allied Military Court has the right to present a petition for review within 30 days of conviction. At the expiration of this period every case, with any petition presented, is reviewed by the competent authority. No right exists to present any further petition.
2. In practice it has been found that persons convicted present innumerable petitions, the vast majority of which have no merit whatever.
3. In the past, these petitions were either disposed of at Regional HQ or forwarded by Regional HQ to this Sub-Commission.
4. It is anticipated that, with the withdrawal of the Allied Commission personnel from Italian Government territory, these petitions will be sent direct by the convicted person or by his family to this Sub-Commission - indeed, a few have already been received.
5. In future such petitions will be perused by this Sub-Commission. If no action is called for, no answer will be sent to the petitioner. If, however, in any particular case this Sub-Commission decides that some action is called for, it will be necessary for this Sub-Commission to request your Excellency to communicate the decision to the petitioner or the authority concerned through the channels of the Ministry, no other channels being available.
6. It is not thought that this will impose any substantial burden on your Excellency's Ministry as the number of cases of the latter class is very small.

1. The facts, as admitted by the accused at the trial, are as follows:-

- a) The accused was owner of the car, which was registered in his wife's name.
- b) The car was licensed for the exclusive use of the Municipio of Frascati for the purpose of transporting sick persons.
- c) The accused took a sick person to Rome.
- d) While at Rome he met some people who asked him to take them to Siena, saying that no pass was required.
- e) He agreed to do this "to support his family"
- f) He carried a loaded pistol for protection.

2. In the opinion of this Sub-Commission, a person who "to support his family" (or, to put it in a different way, "for personal profit") deliberately drives his car, licensed only for use by the Municipio for the transport of the sick, to Siena without a permit and carries with him a

loaded pistol has no good reason for complaint if he is sentenced to imprisonment for 6 months.

3. While no charge was laid in respect thereof, it is clear that this trip to Siena must also have involved the wrongful use of a substantial amount of petrol.

4. In the circumstances, it is not intended to interfere with the sentence which has already been affirmed on review.

Enclosed are informal petitions on behalf of GIACOMIA Luigi and GIACOMIA Bartolo, two of the 26 accused sentenced to imprisonment in the above case tried by a General Military Court at Palermo in October 1943. The record is also enclosed for your consideration and any action you deem necessary.

REASONS.

1. Both prisoners have not served half of their sentence of 3 years and both are suffering from complaints which cannot be properly treated in Sicilian prisons - See medical reports attached to the petitions. It will be noted that the one man was suffering from epilepsy at the date of the trial.

2. The record shows that the Court was impressed with the fact that these rioters were Anti-Fascist, were hungry and had some justifiable grievances against officials in the town. It was however properly considered that it was necessary to firmly discourage this method of redressing grievances. It is now felt that the altered conditions here particularly from the Allied point of view will justify some further leniency.

RECOMMENDATION.

That sentences be reduced from 3 years to 2 years. It will be noted that of the 26 accused sent to prison only 5 including the 3 mentioned above are still serving sentences. The others are:-

PASIVIGNO, Gaetano	3 years
MARINARO, Mariano	3 years
PICANO, Francesco Paolo	2 years

It is suggested that if the petitions are favourably considered similar treatment should be accorded to these three others.

2. Defendant was found in possession of a loaded pistol during hours of curfew on the 3 July 1944. He was tried in a Superior Court and sentenced to serve a term of three years. The case was reviewed by Allied Commission Headquarters, and the judgment affirmed. Subsequent thereto the defendant filed at intervals three different petitions which were overruled because no new facts were presented which would warrant a modification of the sentence. The fourth petition dated 28 February, 1945, has been filed and is up for consideration. X

3. It is apparent from the evidence in the case that the defendant was in possession of a loaded fire-arm during the hours of curfew, and it is possible that he was not bent on any good purpose. The unlawful possession of fire-arms is a menace to good order and to the security of the Allied Forces and civilians alike. It is believed that the Trial Judge intended to impose the sentence which would have a deterrent effect on possible future violators. However it is believed that if the same case were brought to trial today under the same charge and specifications, the Trial Judge would be much more lenient in the length of the term imposed. As a general rule a term of imprisonment for one year has been the maximum sentence imposed by Military Government Courts where the accused were convicted of illegal possession of fire-arms. X

4. In view of the above, and of the defendant's good conduct during the eight months of the three years term, which

he has already served , coupled with economic needs of the family of the defendant, the writer believes that the sentence should be modified to read "three years imprisonment, with two years suspended on good behaviour".
