SUBJECT: Sindaco of Vercelli.

TO : U.A. Section H.Q. A.G.

Reference your 9736 of 29 December.

1. On 22 Dec. 45 the Sindaco of Vercelli appeared before a Summary A.M.G. Court on a charge of disobeying an order: the case was adjourned as it was thought locally that a legal officer should hear it.

2. The Sindaco lodged an appeal to the Regional Commissioner against the order, originally given in August 45, and which he claimed he had fulfilled as far as he could (a) by reinstating an employee as ordered and (b) calling on the Giunta to authorize him paying arrears of salary as ordered.

3. The Giunta refused the authority which the Sindaco claimed he required and threatened to resign: reasons not given officially. It was suggested to them that their timing was faulty as the case was still undecided, and anyway the Sindaco had appealed against the order given to him.

4. Investigation of the appeal against the order, which was by a P.O. no longer available confirmed by two others not available, indicated clearly that (a) it had been given without understanding the legal and factual position and (b) even had there not been this failure to understand the order should not have been given by A.M.G. as there were normal Italian judicial channels open to adjust any grievance. The order was therefore rescinded.

5. At a hearing in Vercelli which aroused considerable interest the decision to rescind the order was communicated and the case against the Sindaco dismissed. From his cheer-leading efforts after the Court adjourned it would appear that he was pleased.
