1. It is understood that the above named was convicted by an AMG Court of stealing and selling WD Petrol, and the sum of 150610 lire was impounded from him. This amount included two cheques valued at 4,0000 lire, which had not been endorsed by the above named and are not therefore negotiable.
2. May it be stated, therefore, whether in these circumstances any action may be taken by you to recover from the civilians concerned the amount for which they had issued these cheques in payment for the WD Petrol.
3. If no such action is possible your advice is requested as to the disposal of these cheques.
