ANCONA Command.

1. Your Amq/11/11 of 14 June 1945 was the first time this case was brought to the notice of this Sub-Commission.

2. If the necessary witnesses are available and an AMG trial can reasonably be arranged I think that IANA should be tried by an AMG Court for the assault on the M.P. In such case account will of course be taken of the period already spent in gaol.

3. If there is any real difficulty about arranging a trial by AMG Court the case should be referred to the Italian Military Tribunal. They can deal with the desertion, the black market activities and the assault on the M.P. at the same time. The evidence of SEIACCO Sebastiano will probably be sufficient for the Italian Tribunal.
