1. I am informed by the P.D.O., Roma Province, that the inaugural ceremony of the Velletri Tribunale, which was due to take place tomorrow, has been indefinitely postponed, because the Presidente and the Procuratore del Regno have decided that the Court is not yet ready to operate.
2. I have also received from the P.D.O., Roma Province, the attached report made by an "Inspector" of the Ministry of Justice, for transmission to the Ministry. An English translation is attached for your own records. Before forwarding on the original report I invite your own attention to this document.
3. I take an extremely poor view of the slowness, and the obvious reluctance, of the officials of this Tribunale to re-open their court in their own proper Tribunale centre. Their dilatoriness compares very unfavourably with the energy and drive which has been displayed by the officials of the Cassino Tribunale, where the court has been open and functioning (in temporary premises at Soru) since 6 July. The difficulties at Velletri are no greater--on the contrary I think they are less--than those at Cassino.
4. I do not feel, however, that there is anything more that I can do about it. I believe it lies now with the Ministry of Justice to instill some greater energy and sense of emergency into officials of this Tribunale. I therefore venture to suggest that, when forwarding attached report to the Ministry, you take the opportunity to express the disappointment of the Allied Control Commission that after all this time so little has been done towards reopening this Tribunale, and to invite them to do their part in instilling into the officials concerned a somewhat greater degree of energy and activity.
5. Pending receipt of your views on this subject I will defer taking the matter up myself with the Primo Presidente of the Rome Court of Appeals--but I am ready to do so if you think it desirable.

War necessities caused the destruction of 4/5 of the buildings which formed the agricultural town of Velletri, but its abundance of forests and its large territory full of vine, where the war damages are only limited, guarantee its resurrection, and already and every day many inhabitants sheltered in Rome and other places, are returning to their fields.

The general conditions of life of the town are nearly negative at present. Shops selling foodstuff, restaurants, hotels are not functioning yet: only some bakers' shops are open which distribute daily rations of 100 gr. per person.

Judicial buildings

On 13 July, according to the order of the Ministry, I went to Velletri together with Maj. Mac Padyan of the British Command at the "Prefettura" of Rome, with the President of the Tribunal Troceni and with the Procuratore del Re Spera, in order to get knowledge of the present conditions of the rooms where the judicial offices were located. I report as follows:

The Palace of Justice in "Piazza del Comune" opposite to the destroyed communal palace, has been hit in several points during the frequent air bombardements and the artillery fighting which lasted several days and covered the area from the plane of Littoria and Cisterna to mount Artenisio near the town, the occupation of which on the part of British and American troops ended the fighting as the Germans withdrew rapidly persuaded by 5th Army.

In several points of the palace there are holes which go from the 3rd floor to the ground-floor. There, where the Pretura offices were, is now only a great heap of rubbish. Only that side to the east which is between the street and the "Piazza del Comune" has remained intact, and there are the audience room, two rooms for the archives, and the lawyers room. The furniture has been destroyed.

The central part of the palace has suffered most damage: the first floor where the council room, the Gabinetto of the President and the clerks rooms for the civil and the penal side were, does no more exist; the same is to be said with reference to the correspondent 2nd floor where the offices of the Procura del Re were. Furniture and archives are among the rubbish.

For the time being it is impossible to locate there the Tribunal and the Pretura; first the rubbish must be brought away, then the palace must be rebuilt, work which will take much time and will cost much money.

Pretura

The second pretore Tartaglione who lives at Velletri, indicated as rooms suitable for the pretura, those of the palace Maggiorelli in Via del Comune. The building is intact, there are good rooms, and there the

pretura offices could function without any difficulty.

#### Tribunal

The question of transferring the seat of the Tribunal to another commune of its district, is to be set aside. This is also the decision of Maj. Mac Fadyan.

The only building which is available, and in good conditions, is that in the centre of Via Menotti Garibaldi next to palace Ginnetti, still the seat of the "circolo professionisti & artisti", which has been duly examined. The 1st floor contains 6 rooms, one of which large (the ball room of the club) which can be transformed into an audience room; the other 5 rooms can be destined to the President, chief clerk, council, lawyers, clerks office; other two rooms can contain the archives which can be located also on the ground-floor which is in very good conditions as the building is only about 30 six years old.

The second floor can be destined to the offices of the Procura. Only at the western corner of the building where it has been hit by a bomb, some little repair is needed.

Therefore, all this building can be the new seat of the Tribunal.

#### Court of Assizes

Its seat was in Via Paolina on the 1st floor of the antique "Monte Frumentario", the rooms of which had been transformed into those for the offices of the court. All this large building has been destroyed by bombardments and shelling; there are only heaps of rubbish.

The court of Assizes must function, when it is necessary for it to sit, in the rooms of the Tribunal which, during the short period of its sitting, either will suspend its own sittings, or the court must fix its trial dates considering also those of the Tribunal.

#### Jail

The building has been badly damaged in its part higher part, that is all the cells which open to the court-yard, specially the eastern part of the terrace on the level of the street has broken down.

That part of the building which has its entrance at the Piazza del Comune, can be used still after the opportundworks of repair have been done.

We could not enter the building as we found it closed; the guards were not on the spot; while, upto yesterday, they brought away the furniture.

The adjacent little house Coraetti which was used as a jail, too, has been hit by bombs and shells in several points and may break down from one moment to the other.

#### Conclusion

In order to get judicial life refunction in a town which war has destroyed, there are necessary the rooms for the offices, the jail which detains the prisoners, the carabinieri who maintain public order

and execute penal sentences; besides, a minimum of means of communication between the judicial centre and its jurisdiction district, and the guarantee of civil life as for foodstuff and flats. All this cannot be obtained but step by step with the gradual return of the life of the town. The commune of Velletri through its sindaco has engaged itself to find out not only the rooms for the offices, but also flats, eventually near the town, for magistrates, clerks and secretaries. Therefore, it is necessary to give the commune a certain autonomy of powers which, to-day, are in the hands of the military authorities of Allied Forces.

The large amnesty already conceded for political and common offences in Southern Italy and now extended also to the Province of Rome, will enable the Tribunal of Velletri to continue to function still for some months in Rome. In the meantime the commune will be able to get ready both the office rooms and the flats for the personnel. When all will be ready and there will be a greater movement in the life of the town, activities which are now insignificant for lack of communications, then, the Tribunal can resume there fully its functions. When the isolation which creates difficulties in the relations of jurisdiction essential to the functioning of public services, with serious consequences specially to the function of justice which is co-ordination of powers, will be surmounted, from the economic efficiency, from the communications, and from public order ~~with the advantage~~ Justice will take advantage because it does not live isolated, but sustained by all its auxiliary organs.

INSTALLATION OF PRESIDENT OF THE SUPREME COURT OF CASSATION

IN ROME on 24 JUNE 1944

A short ceremony took place at the Palace of Justice at 1200 hours on Saturday when H.E. the Minister of Justice, Umberto Tupini reinstated officially H. E. Ettore Cosati to the First Presidency. The latter aged of 71 had crossed the German lines in Jan 1944 to join the Badoglio Government.

While the Germans were in occupation, the Supreme Court had been subjected to very strong pressure from the Republican fascists who were anxious to obtain the consent of the Counsellors to the transfer of its seat to Prescie.

On the whole the Supreme Court resisted successfully. Many of its members went into hiding and sixty five were dismissed forthwith for refusing to join the Fascist Government in the North. All but a very few refused to take the republican oath and when three sections of the Supreme Court were opened in Brescia by the Fascists only two former Counsellors had made the journey from Rome.

During this period the Supreme Court dealt only with routine matters and refused to take any decision which could have prejudiced its position and the Italian Judicial Organization. By reinstating the First President and taking the necessary steps for an early start of the normal activities of the Supreme Court, the Allied authorities are putting an end to the judicial chaos which has been prevalent in Fascist Italy between the 8 September and the liberation of Rome by the Allies. This was pointed by both the Minister and the First President, who asked that a special message of thanks be conveyed to Sir Harold Alexander from all the Magistracy of Italy.

It is expected that the first official sitting of the Supreme Court will take

Fascist Government in the North. All but a very few refused to take the republican oath and when three sections of the Supreme Court were opened in Brescia by the Fascists only two former Counsellors had made the journey from Rome.

During this period the Supreme Court dealt only with routine matters and refused to take any decision which could have prejudiced its position and the Italian Judicial Organization. By reinstating the First President and taking the necessary steps for an early start of the normal activities of the Supreme Court, the Allied authorities are putting an end to the judicial chaos which has been prevalent in Fascist Italy between the 8 September and the liberation of Rome by the Allies. This was pointed out by both the Minister and the First President, who asked that a special message of thanks be conveyed to Sir Harold Alexander from all the Magistracy of Italy.

It is expected that the first official sitting of the Supreme Court will take place early in July. It will be the first of the great Italian institutions to resume its work in the capital and the national and even international importance of such an event cannot be over emphasized.

1. Rome Province.

I have to report that Rome Province was transferred to control of Region IV on 15 June 1944. Many parts of the province have been seriously devastated, and prior to the handing over it appears that little or no legal work had been done either in connection with A.M.G. Courts or in connection with the resuscitation of Italian Courts. Lieut. Morris, who had been sent forward as temporary Provincial Legal Officer, had in fact of necessity been employed as a Provincial Officer in one of the worst devastated localities, and had had no opportunity of discharging his legal duties. As from 15 June 1944 Major MacFadyean has taken over as Provincial Legal Officer and Lieut. Morris has now reported to the S.I.C., A.M.G., Rome Area. Up to-date I have no report from Major MacFadyean of the progress he has made. Copy of Report to me by S.I.C. 5th Army (Field) is attached hereto.

2. Littoria Province.

Excellent progress continues to be made. Records of cases tried in A.M.G. Courts have commenced to reach this H.Q. and appear to be well kept. With regard to Italian Courts, I attach hereto copies of reports rendered to the Provincial Legal Officer by the acting President of the Tribunale and the Pretore of Fondi, which give some idea of present conditions and prospects. The Provincial Legal Officer has written an official letter to the President of the Tribunale instructing him as to the conditions under which Italian Courts will be required to function. Since the date of the attached reports the Procuratore del Re and two of his secretaries have been found in Rome, and are being dispatched to Littoria to resume their duties. The return of the Procuratore del Re has been specially authorized by the Regional Commissioner. At the request of the Procuratore Generale the Procuratore del Re will also give some attention to the Courts in Frosinone and Cassino districts, both within the province of Frosinone. The Provincial Legal Officer of Littoria reports that the Preture Courts have already

little or no legal work had been done either in connection of Italian Courts. A.M.G. Courts or in connection with the resuscitation of Italian Legal Lieut. 2. Littoria Province.

With regard to Italian Courts, I attach hereto copies of reports rendered to the Provincial Legal Officer by the Acting President of the Tribunale and the Pretore of Fondi, which give some idea of present conditions and prospects. The Provincial Legal Officer has written an official letter to the President of the Tribunale instructing him as to the conditions under which Italian Courts will be required to function. Since the date of the attached reports the Procuratore del Re and two of his secretaires have been found in Rome, and are being dispatched to Littoria to resume their duties. The return of the Procuratore del Re has been specially authorised by the Regionale Commissioner. At the request of the Procuratore Generale the Procuratore del Re will also give some attention to the Courts in Frosinone and Cassino districts, both within the province of Frosinone. The Provincial Legal Officer of Littoria reports that the Preture Courts have already commenced some of their preliminary work and that they should be fully open within a week. He says that at present it appears unnecessary to make any further appointments.

3. Frosinone Province.  
 Lt. Col. Purnell has just returned from spending four days with the Provincial Legal Officer, whom he has been assisting in the task of

surveying the position with regard to Italian Courts and Judicial Officials within that province. He reports that within the Tribunale District of Frosinone pretori or vice-pretori are present and Court-rooms are available at Paliano, Anagni, Ferentino, Veroli and Ceccano. These Courts are expected to begin functioning straight away. Pretori of Frosinone and Alatri are expected to return within a week. Four of the six Judges of the Tribunale have been found at Alatri, but there is no suitable building in this town. The Vice-Procuratore has also been located. It has been ~~Provisionally~~ arranged that the Tribunale will function in Frosinone, where a building can be made available in about a week. There has been no opportunity as yet of surveying the situation in the Cassino Tribunale district at the Southern end of the Province. It is known that most of the towns in this area are very badly damaged. Information with regard to this district is being collected by the Provincial Offices.

4. Provinces under Army Control.

Provincial legal Officers of Rieti and Terni are already with their provincial teams. Capt. Aulisi was sent forward yesterday to take over as Provincial legal Officer of Viterbo. Capt Falk is going forward to-day to join the Perugia team.

Legal Division Reports.

TO : R.L.O. Region IV (through R.O.)

.....

1. Personnel. Lt. P.A. Morris who was assigned for duty as Provincial Legal Officer, was issued with 200 copies of each of the Proclamations and General Orders and with a supply of legal forms by this HQ. No reports have been received from him and it is believed that owing to shortage of personnel he has been acting as C.A.O. in the Valmonte area.

2. It was understood that Major Hendrickson would instruct either Major Elder or Major Macfadyen to report to the Provincial Commissioner for duty in the Province, but so far as is known neither has as yet done so. It may be that other arrangements are now contemplated.

3. Proclamations. Proclamations Nos 1 - 4, Notices and General Order No. 1 have been posted in all Communes with the possible exception of one or two in the Alban Hills, which were almost totally destroyed (e.g. Ariccia, Lanuvio). It is probable that these have since been covered.

4. A.S.G. Courts. No returns have been rendered of cases tried in the Province. South of Rome the population was dispersed in the hills and north of the city the Army moved too fast to provide any legal business for the Corps SAs. (Moreover their chief customer, the C.R.F. was not active in this area).

4. Italian Courts.

(i) Velletri Tribunale - Conditions in this district are very bad and it is likely to be some time before the Courts can function effectively. The buildings at Velletri itself are either in ruins or seriously damaged, and the towns of Albano, Anzio and Genzano where there are Preture, are reported 90% destroyed. At Segni the Pretura building is undamaged but no judicial officials had returned at the date of the report.

(ii) Rome Tribunale: The Provincial Commissioner has had an interview with the Procuratore Generale, Comm. Gaetano Saccentino and apart from difficulties of transport and communications, there seems to be no reason for any interruption in the work of the Courts in the City. With regard to the Preture in the country districts, the following reports have been received :-

Presenti: Town <sup>O</sup>ld buildings badly damaged <sup>O</sup> Vice-Pretore Pizzino Agostino present.

Civitavecchia: Pretura and prison destroyed, but there are barracks available for the latter purpose. The Pretore, Dott. Giusto Manunta is acting as Sindaco and the Carcelliere, Selis Augustino is also present in the town.

Bracciano: Pretura in good condition and Court open under one Carnivale Marco (Pretore?)

Castelmovo: Buildings undamaged. Di Simoni Emilio in charge.

5. Law and Order: Reports indicate that conditions to date are satisfactory. Difficulties are soon likely to arise over the question of arms as in many Communes GAGs have encountered Partisan groups well supplied with weapons of all kinds. Their attention has been firmly directed to the order requiring arms to be handed in.

6. Jurisdiction: Rome Province will pass from AMG 5th Army to the full jurisdiction of Region IV with effect from 1200-hours on 15. 6. 44.

CONDITION OF THE COURT'S LOCALS

The building, recently constructed, has been little damaged by air-raids and shells. All the crystals are missing and the window frames are broken.

FURNITURE

Part of the rich and new furniture has been brought away

by the German troops and Italians, and part of it has been seriously damaged. There are no more typewriters, carpets and the safety case in the office of the Cancelliere Capò has been opened and emptied. They brought away all the leather from the chairs. But, even of all this, part of the furniture has been saved because hid in the cellars. Some of such furniture is in the American offices in front of the Court Building.

#### REGISTERS = DOCUMENTS = BOOKS

Part of them has been brought away or tore, and part of them has been thrown on the floor among broken glass and rubble.

Since the last week I gave orders to clean the rooms. In fact some workmen, found for me by the technical office of this Comune, are working under the direct control and that of the Cancellieri Mola and Abenda. They are putting in order the books, the registers and every such important thing. This work is hard and requires a long time because of the damage made. Although the two halls of audience have already been put in order and can be used.

#### JAILS

Actually are functioning, while they had been left empty after the first bombings, and exactly the 25th of Jan. 1944, because about 30 prisoners escaped that same time.

I think it necessary to say that after the landing at Nettunia, being Littoria bombed from the air and the sea, it was impossible to circulate because of the danger of death, which was continuous, (many citizens were killed); people lived in the cellars till the German troops enforced them to evacuate.

In my quality of Pretore Titolare of the District of Fondi I furnish to this Command the following informations about the condition and the functioning of the Pretura and the prisons by me managed:

The district of Fondi, which enters the jurisdiction of the Corte d'Appello of Rome and that of the Court of Littoria, is composed by the following Communes: Fondi, Itri, Sperlonga, Monte S. Biagio, Lendola and Campidivole.

The office of the Pretura was composed, at the date Sept. 9th 1943, by the following functioners:

The first four have their office at Fondi, the fifth at Lendola, the sixth at Itri, the seventh at Naples and Monte San Biagio, the eighth, ninth, tenth and eleventh at Rome, Irtoria and Fondi. The jail, managed by the Prefore, was guarded by the following personal: Masucci Bartolomeo - chief watch-man-, Peruzzi Giovanni, vice watch-man-, Masucci Marianna - watch-lady-. Physician of the jail was the Dr. Silvio Liguri.

Depend from the Pretura of Fondi the following Station Commands of the CC.NR.: Fondi, Itri, Monte San Biagio and Lendola, respectively commanded by the following under-officers: Maresciallo Maggiore Di Prosperò Angiolino, Maresciallo Maggiore Vitale Alessandrò, Maresciallo Maggiore Tancredi Scarpato Arturo, and Brigadiere D'Aprile Vincenzò.

All the functioners of the Pretura and of the jail are presently at Fondi and they have already presented themselves to me. About the lawyers: The first three are at Fondi, the rest of them at Monte San Biagio, the last three at Rome, and the fourth and the fifth are probably respectively at Lendola and Itri. Each Commander of the CC.NR.'s is in his Station.

Since the date Sept. 9th, 1943 the Pretura office has not been functioning because of the interruption of the normal course of the civilian affairs and because of the sabotage of the State's institutions operated by the Germans and Fascists. This matter of fact with adjoint intrusions and impositions by the German invaders comforted me in the resolution to stop every activity of the office, and this to not aserve the justice to the German domination. This is why all the functioners of the Pretura kept themselves away from civil affairs and from the fascist elements: whom took for themselves all the public offices and command places in Fondi.

I had to hide myself upon the mountains of the Comune of Campo-Gimelle to avoid the researches of the above mentioned figures and the German Police.

Following the evacuation of the city; operated in October 1943, all the buildings were emptied by the Germans. In the Pretura was stolen the deposit of stamped paper for a value of 4000 Liras, and a typewriter "Olivetti" new model and bought a short time ago. After the bombardments, which had place Nov 2nd; 1943 and Jan. 6th, 1944, the locals of the Pretura were seriously damaged. As soon as I had been informed about that, I went at Fondi Jan. 8th, 1944, but I did not succeed to save the papers and documents of the office, because of another bombardment which caused the complete evacuation of the city, which was being again populated since the last November. I have been able to save another typewriter "Olivetti" which I gave to the Secretary of the Comune, Fortunato Aurelio, so that he could put it there other of the Comune. But Fortunato has lastly informed me that even this typewriter has been lost.

In consequence of the continued violent air bombardment of the city, the building of the Pretura is actually all demolished. The office was placed at the fifth floor of the first building at Giambattista Vice Street in Fondi. The entrance of this street is completely blocked by a pile of rubble. The floors of the building have been blown down so that the documents of the office are buried under the rubble. I talked with the Mayor and the technical Manager of the work of cleaning about removing the rubble of the building of the Pretura and they promised me that in the shortest possible they will send some workers to do it. I gave dispositions to one of the functioners of the office to see for the documents that should be found and to bring them in the new office. This new office, for the moment, has been installed in the third floor of a building in 28 Ottobre Street.

I have already given the start to the most urgent cases, and to the work of organization of the office. The necessary instructions I gave to the dependent Station Commissaris the necessary instructions for the ascertainment of the misfacts containing themselves in the limits of the Italian laws. Within the next days I will begin to settle all the matters which have troubled Poggioredda during the period that goes from Sept. 9th. to the day of the liberation. A great difficulty for the regular functioning of the office is consisting in the loss of the registers and by the loss of books, stamped paper and other articles. I confide, though, in the help of this Command for the paper, ink, etc. and I promise to encourage with examples my dependent functionaries so that they would surpass all the difficulties which they should meet during the delicate and difficult administration of the justice.

The prison has not been seriously damaged as the building of the Prefecture. The prison is situated in the outskirts of the city, and exactly in Piazza Square No. 1. It is composed as the following: a large room, three rooms for prisoners (one of them for women), two safety jails, home for the watchman composed by three rooms, one room for the vice "custode" and one room used as office. The large room, two of the three rooms for prisoners and the two safety jails have not been damaged; these locals still have iron bars at the windows and can be used for the detention of prisoners. The safety wall of the prison has been damaged. The other locals of the prison have been damaged too; windows broken, the iron bars at the windows have been loosened and in some of the walls are holes. In conclusion the building can still be used, momentarily, for the holding of prisoners, but there is no material as blankets and chairs. I advised the vice "custode" Bazzardi to move in the building so that he may watch it and settle the prisoners.

Since Sept. 9th, 1943 the prison has not been functioning for the normal administration of justice. In a first time the Germans and fascists invaded the prison and sent out of it watch-men and prisoners. Afterwards they used the locals as hospitals and at last they used them as prisons for the people they arrested.

In regards of the service I have already given instructions to the functionaries so that they should prepare the relative registers, communicates the news and give instructions in relation with the Italian laws. I think that even this other branch of the service will soon be functioning in a normal way.

I think it right to communicate to this Command that all the officers of the Prefecture and I are living out of town because there are no comfortable houses in the city, and for such reason we have to walk for five kilometers on a bad road to go to our office. I do such communication asking for the particular transfer indemnity, according to the law, or a special increase.



SUBJECT: Rome Province (5th Army Area)  
Legal Division Reports.

TO : R.L.C. Region IV (through R.C.).

1. Personnel. Lt. T.A. Morris who was assigned for duty as Provincial Legal Officer, was issued with 200 copies of each of the Proclamations and General Orders and with a supply of legal forms by this HQ. No reports have been received from him and it is believed that owing to shortage of personnel he has been acting as C.A.O. in the Valmontone area.

It was understood that Major Hendrickson would instruct either Major Elder or Major Macfadyen to report to the Provincial Commissioner for duty in the Province, but so far as is known neither has as yet done so. It may be that other arrangements are now contemplated.

2. Proclamations. Proclamations Nos 1 - 4, Notices and General Order No 1 have been posted in all Communes with the possible exception of one or two in the Alban Hills, which were almost totally destroyed (e.g. Ariccia, Lanuvio). It is probable that these have since been covered.

3. A.M.G. Courts: No returns have been rendered of cases tried in the Province. South of Rome the population was dispersed in the hills and north of the City the Army moved too fast to provide any legal business for the Corps CACs. (Moreover their chief customer, the C.E.F. was not active in this area).

4. Italian Courts.

(i) Velletri Tribunale - Conditions in this district are very bad and it is likely to be some time before the Courts can function effectively. The buildings at Velletri itself are either in ruins or seriously damaged, and the towns of Albano, Anzio and Genzano where there are Preture, are reported 80% destroyed. At Segni the Pretura

building is undamaged but no judicial officials had returned at the date of the report

(ii) Rome Tribunale: The Provincial Commissioner has had an interview with the Procuratore Generale, Comm. Gaetano Cosentino and apart from difficulties of transport and communications, there seems to be no reason for any interruption in the work of the Courts in the City. With regard to the Preture in the country districts, the following reports have been received :-

Frascati: Town and buildings badly damaged. Vice-Pretore, Pizzino Agostino present.

Civitavecchia: Pretura and prison destroyed, but there are barracks available for the latter purpose. The Pretore, Dott. Giusto Menunta is acting as Sindaco and the Cancelliere, Selis Augustino is also present in the town.

Bracciano: Pretura in good condition and Court open under one Carnivale Marco (Pretore?).

Castelnuovo di Porto: Buildings undamaged. Di Simoni Ennio in charge.

5. Law and Order: Reports indicate that conditions to date are satisfactory. Difficulties are soon likely to arise over the question of arms as in many Communes CAOs have encountered Partisan Groups well supplied with weapons of all kinds. Their attention has been firmly directed to the order requiring arms to be handed in.

6. Jurisdiction: Rome Province will pass from AMG 5th Army to the full jurisdiction of Region IV with effect from on 15. 6. 44.
