1. Colonel Wilmer has left this Sub-Commission and I am replying to your 11144/313/CA of 8 Nov 44.

2. I feel that I should tell you that according to Italian law the criteria which you give for "statal" and "parastatal" institutions is not sound. It is apparently agreed by all jurists that the criteria of financial interest and control are not sufficient for the classification of parastatal institutions.

3. I am not therefore as a rule classifying institutions as parastatal but I append the following information as to their financial interests :-

Ala Littoria - precise information not obtainable. The State is thought to own all the capital. There was originally a private shareholding of L300,000 by Soc. Idrovolanti Alta Italia and this may still exist.

Banco di Napoli) Not owned by State - controlled by State in same
Banco di Sicilia) manner as other public institutions.

I.N.A.) Funds owned by individuals. Largely controlled

R.A.O.I. Not owned by State. Controlled by it.

S.A.A Tabacchi Italiani Banks of Naples and Sicily own jointly L5,000,000 - otherwise State owned.

4. The above remarks apply to both lists attached to your letter, and covers all the cases except FAMAO in Eritrea. Detailed information is not available but it seems that most of its funds are owned by individuals.

Dear General W. D. Leahy

1. In the absence of Col. Macrory I write to ask your assistance in the classification of the Institutions shown in the attached list, which for various reasons including the disposal of their property and assets it is necessary to classify either as "Parastatal" or "wholly state owned".
2. The criteria on which this classification is to be based are "financial interest" and "control". If in any of these concerns there is a private financial or other interest however small or if there is an interest by another parastatal concern, it is to be classified as parastatal, but if the entire control and financial interest is in the state it is to be classified as wholly state owned.
3. I am compelled to ask your assistance in this matter as the head offices and all the records of the Institutions referred to are in Italy and local information on the subject is very contradictory.
4. In each case I have included a short summary of the information we are able to obtain from local enquiry.
5. I should be very grateful if you would classify them according to the evidence available in Italy stating brief particulars of the private interests involved in the case of those that you consider to be parastatal

1. ALA LITTORIA. Operates Airports, is controlled by the State and the State owns most of its capital. But there is apparently a small private shareholding.
2. BANCO DI NAPOLI. - The original capital was subscribed by two private individuals, but now no private interests are involved. The profits accumulate to form a reserve. State seems to have had a very high degree of control.
