#### ROAD TRANSPORT

#### PROCLAMATION No. 91

I, CHARLES HENRY GORMLEY, Colonel, Officer of the Most Excellent Order of the British Empire, hereby proclaim:—

#### ARTICLE 1.

Orders Nos. 3 and 35 are hereby repealed, but so that any person who has committed any offence thereunder prior to the date hereof may be convicted at any time.

#### ARTICLE 2.

The Road Transport Controller is hereby declared the competent authority for the whole of Tripolitania to exercise the powers of the Prefect and the Reale Automobile Circolo d'Italia in respect of mechanically propelled vehicles and trailers and of the Prefect in respect of drivers of mechanically propelled vehicles for all the purposes of the Italian Law specified in the Schedule hereto in force in the Territory. The said Italian Law so far as not inconsistent with the provisions of this Proclamation or of any Regulation made hereunder and so far as it is capable of taking effect shall continue to apply and take effect.

#### ARTICLE 3.

- (i) All mechanically propelled vehicles or trailers the use of which in the Territory without a circulation licence Italian Law prohibits shall be registered in the appropriate register according to Italian Law unless the Road Transport Controller has by writing under his hand exempted such vehicle from the necessity of registration.
- (ii) No unexempted vehicle shall be used unless a valid circulation licence has been issued in respect of it.
- (iii) Any exemption granted may be made conditional on the performance or observance of any condition specified in the writing granting exemption.

#### ARTICLE 4.

Save as may be otherwise provided by Regulation

- (i) All mechanically propelled vehicles shall also require a permit for the user of the vehicle;
- (ii) permits shall be of three classes, bus permit, B.M.A. sub-contractor's permit and civilian vehicle permit;
- (iii) permits shall be issued for such periods as the Road Transport Controller or any officer authorised by him thinks fit;
- (iv) the Road Transport Controller may in any such permit specify conditions subject to which such permit is issued including a condition that

the permit shall be valid only for journeys in respect of which a work ticket is issued and that the instructions on the work ticket be observed.

#### ARTICLE 5.

No person shall reconstruct any mechanically propelled vehicle or trailer without the Road Transport Controller's consent in writing. Reconstruction shall include the complete re-boring of an engine and any work as a result of which the value of a mechanically propelled vehicle or trailer exceeds by M.A.L. 7,200 its value before the execution of such work.

#### ARTICLE 6.

No person shall purchase or sell or deal in any manner whatsoever in any mechanically propelled vehicle or trailer or in any motor vehicle spare parts, or accessories or supplies of any kind without the written permission of the Road Transport Controller, who may attach such conditions to his permit as he may think fit.

#### ARTICLE 7.

The Chief Administrator may prescribe Regulations to provide for

- (a) the organisation of B.M.A. contractors into groups and for the control of such groups;
- (b) conditions in substitution for or in addition to those required for the granting of any driving licence or circulation licence under Italian Royal Decree of 3rd April 1937 No. 1755:
- (c) any matter dealt with in Article 4 of this Proclamation and generally for any matter necessary to carry into effect this Proclamation and the Italian Law affected thereby.

#### ARTICLE 8.

The Road Transport Controller or any officer authorised by him may by writing under his hand require any person to furnish particulars of any mechanically propelled vehicles, trailers, motor vehicle spare parts, tyres, or any other motor vehicle supplies in the possession or under the control of such person. Where such particulars are required from the inhabitants as a whole, or from any class or section of them, they shall be required by Regulation under Article 7(c). No person shall withhold any part of the information required by such writing or Regulation, or give information which is false in any material particular.

#### ARTICLE 9.

#### Any person who

(a) For the purpose of obtaining from the Road Transport Controller any driving licence, circulation licence, vehicle permit or work-ticket, or any mechanically propelled vehicle, trailer, vehicle supplies or stores, with.

holds any material information or makes a statement false in any material particular;

(b) Falsifies any document used for carrying this Proclamation into effect, or without authority makes any such document in whole or in part or alters it in any material particular;

(c) With intent to mislead alters, obscures or obliterates any distinguishing mark on any mechanically propelled vehicle, or trailer;

(d) Evades, or attempts to evade or fails to comply with any of

(i) the provisions of this Proclamation,

(ii) the provisions of any Regulation made hereunder,

(iii) the conditions of any permit of which he is aware issued under this Proclamation or under any Regulation made hereunder,

shall on conviction by a Summary Military Court be liable to imprisonment up to five years or to a fine up to M.A.L. 96,000 or to both such imprisonment and fine.

#### ARTICLE 10.

Where any person has been convicted of any offence under this Proclamation in connection with any mechanically propelled vehicle or trailer, the Court may, on being satisfied that the Accused is not the owner, or duly authorised agent of the owner, of such vehicle or trailer and that neither any order for restitution nor any order under Proclamation No. 85 can be made, order the sale of such mechanically propelled vehicle or trailer in any manner which will ensure a fair price and may further order that the proceeds of sale be paid to the Custodian of Enemy Property or be dealt with as may be just.

#### ARTICLE 11.

In this Proclamation and in any Regulation made hereunder the expression a mechanically propelled vehicles shall unless the contrary appears by the context include the vehicles described in Article 54 of the Italian Royal Decree of 3rd April 1937 No. 1755.

#### FOOT AND MOUTH DISEASE (AFTA EPIZOOTICA)

#### REGULATION No. 10

Regulation prescribed by the Acting Chief Administrator under Italian Royal Decree of 20th March 1933 No. 702 and Italian Royal Decree Law of 3rd December 1934 No. 2012.

- Until further notice the purchase, transfer or sale of Bulls, Bullocks, Cows, Heifers, Calves and Pigs, or the movement of any such animals for any purpose from the place where they are normally kept is prohibited within the Municipality of Tripoli and within a zone of 25 kilometres from its boundarics.
- Any person in possesion of any animal of any kind suffering from Foot and Mouth Disease (Afta epizootica) will immediately on discovering the disease report to the nearest Civil Affairs Officer.
- Any person who contravenes the provisions of this Regulation shall be guilty of an offence and liable on conviction by a British Military Court to imprisonment for a term up to one month or to a fine up to M.A.L. 2,500.

#### ROAD TRANSPORT RECULATION No. 111

Regulation prescribed by the Acting Chief Administrator under Article 7(c) of Proclamation No. 91.

- 1. All persons who are now in possession of any mechanically propelled vehicle or trailer in respect of which no valid circulation licence (licenza di circulare) has been issued, shall declare the same to the Road Transport Controller on or before the 31st day of May 1945.
- 2. All persons who come into possession at any future time of any such vehicle shall forthwith declare the same to the Road Transport Controller.
- 3. The declaration shall so far as possible include such particulars as would be necessary to complete a circulation licence (licenza di circolare) in respect of the completed vehicle, and also an explanation of the circumstances in which the vehicle came into the possession of the person who declares it.
- 4. #### ROAD TRANSPORT PROCLAMATION No. 91

I, CHARLES HENRY GORMLEY, Colonel, Officer of the Most Excellent Order of the British Empire, hereby proclaim:—

#### ARTICLE 1.

Orders Nos. 3 and 35 are hereby repealed, but so that any person who has committed any offence thereunder prior to the date hereof may be convicted at any time.

#### ARTICLE 2.

The Road Transport Controller is hereby declared the competent authority for the whole of Tripolitania to exercise the powers of the Prefect and the Reale Automobile Circolo d'Italia in respect of mechanically propelled vehicles and trailers and of the Prefect in respect of drivers of mechanically propelled vehicles for all the purposes of the Italian Law specified in the Schedule hereto in force in the Territory. The said Italian Law so far as not inconsistent with the provisions of this Proclamation or of any Regulation made hereunder and so far as it is capable of taking effect shall continue to apply and take effect.

#### ARTICLE 3.

- (i) All mechanically propelled vehicles or trailers the use of which in the Territory without a circulation licence Italian Law prohibits shall be registered in the appropriate register according to Italian Law unless the Road Transport Controller has by writing under his hand exempted such vehicle from the necessity of registration.
- (ii) No unexempted vehicle shall be used unless a valid circulation licence has been issued in respect of it.
- (iii) Any exemption granted may be made conditional on the performance or observance of any condition specified in the writing granting exemption.

#### ARTICLE 4.

Save as may be otherwise provided by Regulation

- (i) All mechanically propelled vehicles shall also require a permit for the user of the vehicle;
- (ii) permits shall be of three classes, bus permit, B.M.A. sub-con-tractor's permit and civilian vehicle permit;
- (iii) permits shall be issued for such periods as the Road Transport Controller or any officer authorised by him thinks fit;
- (iv) the Road Transport Controller may in any such permit specify conditions subject to which such permit is issued including a condition that

the permit shall be valid only for journeys in respect of which a work ticket is issued and that the instructions on the work ticket be observed.

#### ARTICLE 5.

No person shall reconstruct any mechanically propelled vehicle or trailer without the Road Transport Controller's consent in writing. Reconstruction shall include the complete re-boring of an engine and any work as a result of which the value of a mechanically propelled vehicle or trailer execeds by M.A.L. 7,200 its value before the execution of such work.

#### ARTICLE 6.

No person shall purchase or sell or deal in any manner whatsoever in any mechanically propelled vehicle or trailer or in any motor vehicle spare parts, or accessories or supplies of any kind without the written permission of the Road Transport Controller, who may attach such conditions to his permit as he may think fit.

#### ARTICLE 7.

The Chief Administrator may prescribe Regulations to provide for

- (a) the organisation of B.M.A. contractors into groups and for the control of such groups;
- (b) conditions in substitution for or in addition to those required for the granting of any driving licence or circulation licence under Italian Royal Decree of 3rd April 1937 No. 1755;
- (e) any matter dealt with in Article 4 of this Proclamation and generally for any matter necessary to carry into effect this Proclamation and the Italian Law affected thereby.

#### ARTICLE 8.

The Road Transport Controller or any officer authorised by him may by writing under his hand require any person to furnish particulars of any mechanically propelled vehicles, trailers, motor vehicle spare parts, tyres, or any other motor vehicle supplies in the possession or under the control of such person. Where such particulars are required from the inhabitants as a whole, or from any class or section of them, they shall be required by Regulation under Article 7(c). (a) For the purpose of obtaining from the Road Transport Controller any driving licence, circulation licence, vehicle permit or work-ticket, or any mechanically propelled vehicle, trailer, vehicle supplies or stores, with.

holds any material information or makes a statement false in any material particular;

- (b) Falsifies any document used for carrying this Proclamation into effect, or without authority makes any such document in whole or in part or alters it in any material particular;
- (e) With intent to mislead alters, obscures or obliterates any distinguishing mark on any mechanically propelled vehicle, or trailer;
  - (d) Evades, or attempts to evade or fails to comply with any of
    - (i) the provisions of this Proclamation,
    - (ii) the provisions of any Regulation made hereunder,
- (iii) the conditions of any permit of which he is aware issued under this Proclamation or under any Regulation made hereunder,

shall on conviction by a Summary Military Court be liable to imprisonment up to five years or to a fine up to M.A.L. 96,000 or to both such imprisonment and fine.

#### ARTICLE 10.

Where any person has been convicted of any offence under this Proclamation in connection with any mechanically propelled vehicle or trailer, the Court may, on being satisfied that the Accused is not the owner, or duly authorised agent of the owner, of such vehicle or trailer and that neither any order for restitution nor any order under Proclamation No. 85 can be made, order the sale of such mechanically propelled vehicle or trailer in any manner which will ensure a fair price and may further order that the proceeds of sale be paid to the Custodian of Enemy Property or be dealt with as may be just.

#### ARTICLE 11.

In this Proclamation and in any Regulation made hereunder the expression a mechanically propelled vehicles shall unless the contrary appears by the context include the vehicles described in Article 54 of the Italian Royal Decree of 3rd April 1937 No. 1755.
