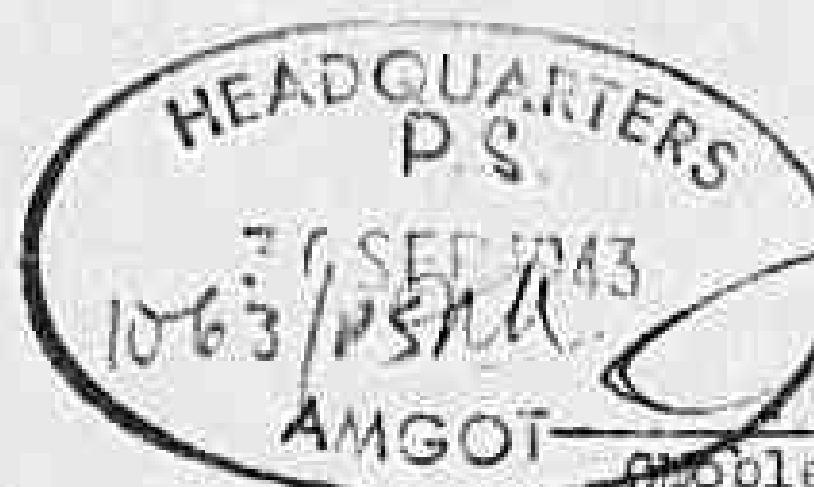

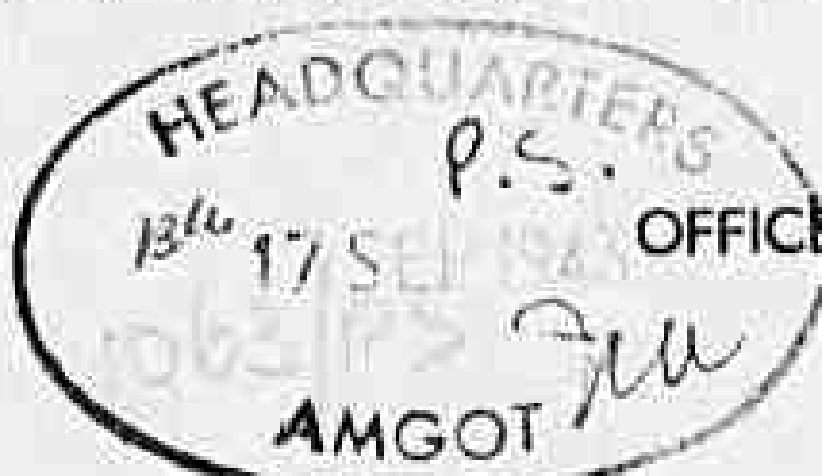

I wish to assure you in these prisons are no hangman nor execution squad.

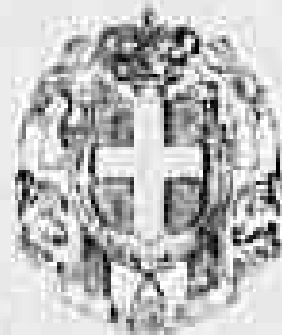
Before the Allied occupation, when it was needed, a platoon commanded by a Captain came from ROME.
