On 20th September 1943 the above named was arrested by Pte. COWAN, 727th Ry. Opng. Bn. for attempting to steal petrol from a military gas dump where the soldier was then employed on guard duty in the vicinity of CALTANISSETTA.

MIANI was given into custody of Military Police and taken to the United States Seventh Army Prisoner of War Enclosure, PALERMO and on 11th October 1943 was transferred to Carceri Giuciziario, PALERMO.

Legal opinion has been obtained and it would appear that the case should be heard by a Superior Court at CALTANISSETTA where the offence was committed (copy attached).

The papers are sent you to arrange for the hearing and transfer of prisoner when he is required to appear.

15 October 1943SUBJECT : Case of MIANI, Angelo, paroled P.O.W.TO : Director of Prisons.

1. Reference your enquiry how the above named prisoner shall be tried.
2. Offences committed by a P.O.W. before parole are triable only by Courts Martial. Proclamation offences committed by P.O.W's after parole may be tried by AMCOT courts. Accordingly this case should be tried in an AMCOT court.
3. The only evidence in the file is the statement of Pte. Cowan, 21 Sept. 43, and that of Sgt. Jablonski, same date. They indicate that three other men were implicated. No report has been received whether any of them has been arrested.
4. It is directed that the case be tried by a Superior Court convened by order of the S.C.A.O. at Caltanissetta. The C.A.P.O. should investigate further if necessary and this prisoner should be tried jointly with the other offenders if possible. From the evidence in the file, the following charges appear appropriate:
 - (a) Violation of Proc. 2, Art. I, Sec 10, entering a prohibited area. Entering area of the 727th Ry. Opng. Bn. protected by barbed wire at Caltanissetta at about 0300 hours 20 Sept. 43.
 - (b) Violation of Proc. 2, Art. II, Sec. 26; Art. III, Sec. 2, attempting to steal property of the Allied Forces. Attempted to steal gasoline at time and place stated under charge (a).
5. It will be necessary to return the prisoner to custody of the C.A.P.O. Caltanissetta.

Subject: Arrest of civilian, Angelo Miano

To: Lt. Smith

This man was picked up by M.P. Roving Patrol at the billet of the 727th Rwy. Opng. Bn. at 0300 hours on 20 Sept. He was caught trying to steal gas along with three other civilians who managed to escape. Pvt. Cowan, Co. A 727th Rwy. Opng. Bn. who was on sentry duty at that time made the arrest.

He was brought to the Provost Marshall's office for questioning and a search of his papers revealed him to be Angelo Miano, Via Terranova No 25. a paroled Italian prisoner of war. He named .Quinta. Calogero, Via LComasco ~~XX~~ Vicino Pozzetto as one of his companions who escaped. Calogero knows the ~~XX~~ other two men. Miano reported that the other three had made trips to the gas dump before.

This outfit claims that this stealing has been going on for some time and amounted to approx. 200 gals.

Miano was turned over to the Civil Police and is being held for further investigation.

His parole papers are attached.

STATEMENT OF SENTRY PVT. COWAN CO. A 727RWY. OP. BN.

At 0300 hrs. on 20 Sept. I was on sentry duty outside the billet of Co. A 727th Rwy. Op. Bn. My duty was to guard a large quantity of gasoline in 5 gal. cans which was stored in a barbed wire enclosure outside the billet. While on guard duty I saw ~~some~~ civilians enter the enclosure and tamper with the gas cans. I then stepped out and challenged them but they started to run. I ran after them and caught one man whom I turned over to the M.P. Roving Patrol which was patrolling the area.

(1) One hundred and twenty six persons are confined in the jail at Nicosia on authority of Procuratora del Re, Palermo.

(2) Many of these persons are listed as having been transferred from Ustica.

(3) There is no record of charges or whether or not convictions have been had.

(4) The Nicosia jail is seriously overcrowded.
