1. With reference to your memorandum of 4 Sept. 1945 inquiries are being made into the character, antecedents and activities of the Questore and Vice Questore, Province of Palermo and of Commissario Lombardo, the result of which will be forwarded when completed.

2. I would remind you, however, that the appointments of high officials of the Agenti di Pubblica Sicurezza must at all times be coordinated by the Public Safety Division HQ.

3. The effect of Proclamation on the policing system generally is being considered at this headquarters.

(b) Changes in the personnel of the Agenti di Pubblico di Sicurezza must be referred to the Public Safety Division for decision by the C.C.A.O. who at present represents the authority of the Central Government."

The effect of Proclamation 13 on the policing system is subject of a memorandum from this Office under date of 11, September, 1943.

2. The report from C.I.C. has been noted and is under investigation; further developments will be submitted later.

SUBJECT: The Questure at Palermo, Sicily.

TO : Assistant A.C. of S., G-2, C.I. Section, Headquarters 7th Army.

1. Information has been received from a most reliable source that in the Questura at Palermo is taking place a secret movement detrimental to the Allied Government, especially Proclamation #13 of 17 August 1943, by which Italian Police are forbidden to arrest individuals without proof of crime committed. This proclamation has been unfavorably received by the more violent element in the Questura where there are several officers who want to continue in the system of the past.

2. The Questore himself, Comm. Gerbo, is said to be an excellent person but he has neither the authority nor the energy to impose his will upon his subordinates. It is reported that the real head of the Questura is the Vice Questore, Modica, who is an authoritarian element, and who during the first days of the Allied Occupation of Sicily appeared to be willing to follow the orders of the Allies. The informant now states that he discusses such orders now and is going to carry out his activities as he wants to. Thus, Modica is carrying out passive resistance and hindering the police work of his organization. Another such element in the Questura is Commissioner Lombardo head of the police office of Resuttano, suburb of Palermo, who contrary to the orders of the Allies continues to arrest people on charges of imaginary crimes. A few days ago he even arrested a rich merchant, Randazzo, and his son under the accusation of looting, a crime of which Randazzo is said to be innocent. In order to put a stop to this passive resistance on the part of the Questura, awaiting broader revisions; informant says it would be well to withdraw Modica as head of the Questura and send him to some other post in the city and that Lombardo should likewise be withdrawn from his present position.

3. For Modica might be substituted a more calm individual, without so much ambition, such as Comm. Castiglione who is at the present time attached to the Prefettura. In such a way, according to the informant, the Questura would be more free to collaborate with the Allies.
