SUBJECT:- Maintenance of Prisons - Finance.

To:- Lt-Col. Allan B. Michell,
Supt. of Prisons.

1. The Finance Officer, Messina has made money available at the same source as before the occupation for the maintenance of State, Provincial and Communal Institutions and payment of salaries.

2. The Finance Officer, Messina will discuss with the C.A.O. Mistretta the Central Prison at Mistretta, and see what arrangements can be made under the circumstances prevailing in this particular case.

3. It is the duty of the Supt. of the Central Prison, Mistretta to come to Messina to obtain his funds or contact the agency who has in the past made these payments, in order to secure his funds.

4. The Finance Officer, Messina has many payments which he controls and supervises through established machinery of the Local Government. He makes no payments as such directly to sub agencies or individuals, except those made before the occupation.

5. I have talked to the Intervente di Finanza M. M. who is going to interest himself at once in this matter.

Some difficulty has been experienced by the Commandante of the Central Prison, MESSINA, in obtaining advances to meet urgent expenses and payment of staff.

Recently he was advised by the S.O.A.O. of the town that to obtain funds a journey to MESSINA was necessary. In an endeavour to comply with this order he met with an accident and is now incapacitated from duty.

This office appreciates the necessity of R.Q. interviews with responsible officials of institutions, but would esteem it a favour, that if essential advances are to be made, and maintenance of a State Prison would appear essential, such could be done through the local S.O.A.O. who has all the documents and information at his disposal.

It is desired so far as possible to unify and simplify the procedure under which advances are made from AMFA to various State and parastatal institution and organizations.

Inevitably in the initial stages many of these advances have been made through channels which were different than the normal ones used by the Italian Government. The Italian Govt. will eventually require to charge the various expenditures to different parts of its Budget and will probably wish to institute its normal accounting and audit checks over the Italian officials actually carrying out the payments. It is accordingly desirable that advances should be made whenever possible so that they come under scrutiny of the accounting or audit official concerned.

In order that the review may be comprehensive I should be grateful therefore if you would advise me of

- (a) the names of the Italian bodies with whom you are in contact, and to which in certain cases advances have been made,
- (b) the title of the head official with whom you deal and with his normal area of jurisdiction (ie, province, group of provinces, region etc)
- (c) the title of any accountant (Ragioniere) or auditor known to be associated with the organization,
- (d) rank at which the organization keeps its accounts,
- (e) the Ministry which controls the organization,
- (f) Any suggestions for the simplification of the procedure under which advances are made.
