

2. The cases referred to and the circumstances attendant upon each are as follows :-

(a) Catania.

In October last it was reported by Colonel Biondi, The Officer Commanding the Guardia di Finanza in Sicily, that there were difficulties regarding the barracks at Catania. These had been requisitioned by the British Marines, and it had not been possible to obtain restitution. In December it was reported that the Marines were not utilising the whole of the premises, that information had been received that the R. Harbour Office was being established in the barracks and it was asked that this should not be permitted, but that the Finance Guards should be allowed to return to the vacant accomodation instead of being distributed in different places in the town.

The SCAO of Catania was asked to take steps to secure, if possible, the return of the barracks, or at least the unoccupied portion of them, to the Guardia di Finanza, but in January it was stated that the premises were occupied by N.C.I.C. and his staff, the Capitaneria di Porto, the R.A.F., and the Ministry of War Transport, and that there was not a vacant room in the building. Further, there was no suitable alternative accomodation in the vicinity of the Port, which has been extensively damaged, and it seemed unlikely that the barracks will be available for the use of the Guardia di Finanza for some time.

There the matter is, the Finance Guards being housed in different parts of the town in quite inadequate accommodation with a consequent loss of efficiency and prestige.

(b) Siracusa

In November last it was reported that the Canadian Troops were occupying the Finance Guards barracks in the town, the latter being obliged to lodge in private houses, and it was asked that they should be moved to alternative accommodation, which had been offered to the Guardia di Finanza, but was not suitable. The SCAC, Siracusa, was requested to enquire into the matter with a view to making arrangements with the Military authorities involved.

In December the Finance Guards were lodged in one large building, which was the best accommodation which could be found, and are so housed at the present time.

3. Whilst it is appreciated that Military requirements must be the first consideration, it was the opinion of representatives at the Conference that as efforts made locally to secure the restoration of these barracks to the Guardia di Finanza had been without success, the matter should be reported to Headquarters with a view to approaches being made to the Military Authorities at a higher level.

4. It is quite apparent that the work of the Guardia di Finanza is of considerable importance at these two large Ports in Sicily, and they are not likely to regain their prestige or efficiency whilst accommodated elsewhere than in the premises which were formerly their Headquarters.
