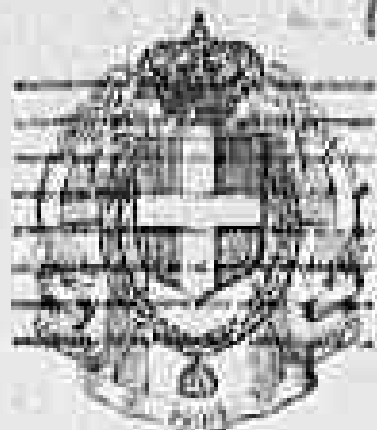

The Maresciallo di Finanza Giovanni FOLIESA belonging to the La Spezia Company, has left la Spezia on April 24th 1945 to join his displaced wife in Soresina (Cremona), has been made a prisoner by the Allies when he travelled across the Appennine (probably on some German truck); at present he is in a concentration camp No. 338 near Pisa, his number being 760417.

This Camp depends of ~~the P.W.E. Command~~ the P.W.E. Command No. 338. Istituto S. Spirito, ~~near~~ corso Umberto 33, Livorno.

Now the family of this petty-officer, his old parents living in Genoa and his wife with a child only few months old living in Soresina, begs this Command to do what is possible to obtain the freedom of their family member.

Maresciallo Follesa has never been a member of the Republican Fascist Party, he was always highly considered by his superiors for his sense of duty, and he always led ~~an~~ a matchless ~~normal~~ life as a citizen with regard to morals and politics.

Besides being an act of justice, his release would be also an act of humanity, his wife being without any means of sustenance, the salary of her husband being suspended since his having been made a prisoner.

The family trusts that ~~and~~ their request will be considered and expresses its heartfelt thanks in anticipation.

Following the occupation of Abissinia, Somalia, Eritrea, Libia, Tunisie and Sicilia by the Allied Troops, many soldiers of the Corps, who were there on Police and tributary duties, were captured or considered P.O.W.

It appears, that only a small percentage continues to carry out their proper services, directly depending on the Allied Commands.

In consideration of the effective strength of the units dislocated in said territories, the following prisoners would appear, included even those captured by the Allies in Greece:

- 1) - R. 55 Officers;
- 2) - " 200 M.C.O.s;
- 3) - " 1300 Privates.

As is known, these ^{are} officers and soldiers, who performed duties as officers and soldiers of the judicial and tributary Police, whose services are indispensable for the immediate efficacious development of the tributary services.

In fact, it is to be noted, that a remarkable number of officers, M.C.O.s and privates of the R.Finance Guard was captured by the Germans and that consequently there is a very heavy deficiency of personnel in the territories of Liberated Italy. It is to be considered, that a noticeable part of the strength disponible is exclusively employed with various Police services on account of the Allies, thus strongly reducing the disponibility of personnel to be employed with the tasks of the institution of the R.Finance Guard.

In consideration of the above, we heartly beg Your Excellency, to act as transmitter of such urgent necessities at the competent Authorities, encouraging the repatriation of all P.O.W. GG.FF. military.

MEMORANDUM TO: Chief Commissioner, Allied Control Commission.

1. This is in reference to your memorandum (ref. CC/C/527) to AFHQ, attention G-5, dated 23 May, above subject, copy attached as Incl. #1.
2. The Public Safety Sub-Commission has, in conjunction with the Italian authorities, prepared lists of CC.RR. & CC.FF. officers who are believed to be Prisoners of War in India and Africa, and for whom application is made for release, in order of priority as shown on attached lists (Inclosures #2 and #3).
3. With respect to the name of General Taddei Leonetto, Incl #2, CC.RR. list; on 14 April 1944, you made a special representation by letter (ref. 302/101/CA) to Hq AAI relative to the release of General Taddei.
4. Note that the name of Capt. CASANO Onofrio, shown on Incl #2, CC.RR. list, 1st priority, was previously included on second Comando Supremo priority list of 25 names sent to AFHQ by you on 22 April 1944 (ref. CC/C/222).
5. In view of AFHQ letter (LGS 014.12) dated 11 May 1944 (copy attached as Incl #4) and your memorandum referred to in para 1 above, it is suggested that you might want to send the enclosed lists to AFHQ for information of G-5 and for such use as G-5 can make of them.

SUBJECT : Application for Release of POW - GCRF and GQTF  
TO : Deputy Chief Commissioner, ACC

1. Herewith are nominal rolls of officers of the GCRF and GQTF who are believed to be prisoners of war in India and Africa.
2. Their services are urgently required in Italy for the maintenance of public order, and particularly at the present time when it can be anticipated that new territory will be occupied and lack of officer personnel is making itself more evident.
3. With reference to General TADDEI, prisoner of war in India, special representations were made by this Sub-Commission to the Executive Commissioner on the 20 March 1944, reference ACC/14601/6/PS, and a letter, reference 302/101/CA dated 14 April 1944, on the subject was addressed by the Chief Commissioner to HQ, AAI.
4. The Chief Commissioner on 27 April 1944, reference CC/6/236, informed this Sub-Commission that another urgent request had been made to AFHQ for the return of all GCRF POW personnel. Also that the verbal support of Generals Wilson and Alexander had been obtained in the matter.
5. At time of writing, it is learnt that 50 GCRF POW personnel (not officers) have just arrived at Naples from Africa.

SUBJECT : Officers, Non-Com., EM/OR's of GGFF P.O.W.

The actual strength of the R. Guardia di Finanza is inadequate for the complex duties of the service. We have been compelled, in fact, to hold in the service officers, non-coms, and soldiers already advanced in age, recall men from retirement and request for an enrollment of 4000 Finanzieri and 300 non-coms. for which necessary measures are about to be approved.

But the situation cannot be examined even in relation to the proximate future because the personnel deficiency will assert itself when the Allied Troops have liberated Rome and the situation will become more critical if we have a sudden collapse of the Germans with the resultant necessity providing for the exigencies of the service entrusted to R. Guardia di Finanza, in all the territory of the nation.

This necessity makes itself felt if we consider that the assignment of personnel situated on the other side of Italy and Balkans, cannot be done immediately because as they gradually return, it will be necessary to examine each case individually in relation to their collatoration with the Germans.

Independently of other measures which must be undertaken to cope with the e/m exigency, I would like to put at the disposal of this Command all the personnel of the R. Guardia di Finanza (officers, non-coms, soldiers (militari di truppa) who are held as prisoners of war by the Anglo-Americans.

Personnel held as prisoners of war are as follows:
