- 1. Two persons are in custody of D.S.O. MALTA, pending investigation of their identity. They are probably Danish seafaring men: one ORLA REQUAT JENSEN alleges that he lost his Registration Certificate (probably a Seaman's Discharge Book) in Syracuse on 11 December 1943: the other KARL JOHAN DIDERIKSEN alleges that his Danish passport (No.27 W 2014 issued in Glasgow 29 May 1941) was lost in Casablanca early in November. These cases have not previously been reported anywhere.
- 2. Information is required whether anything is known of these men or of their identity papers in your Region. Region 111 has no information.
- 3. In order to avoid delay, please reply direct to D.S.O. Malta, sending a copy of your letter to this Headquarters.

- 1. The two persons named in the attached message received from D.S.C. Malte are probably Danish scafaring men who have lost their identity papers and are in custody pending investigation.
- 2. It would appear that D.S.C Malta requires information on the fellowing points:-
 - (a) As to whether anything is known in AMG Regions concerning:-
 - (i) ORIA REQUAT JE SET
 - (ii) KAR JOHAN DIDERIKSEN, and
 - (b) as to whether anything is known concerning the identity papers lest by these men. (The Certificate of Registration lost by Jensen is propably the English equivalent of a Season's Discharge Book issued by the Board of Trade).
- 5. Nothing is known at this Headquarters concerning these matters, and it seems that the message has passed through Region III without comment.
 - 4. I suggest a copy of the message be forwarded to Regions I and

Il for action as to whether anything is known of the persons maded on the documents which are alleged to be lost. In order to avoid delay, Regions should be instructed to really direct to D.S.O. Malta.

5. D.S.O. Malta might be informed of the action taken in this matter by this headquarters.
