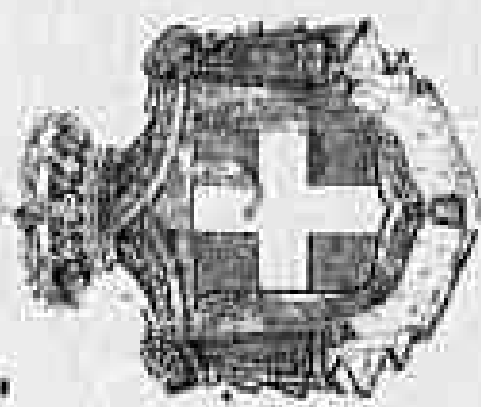

TO : Headquarters Commandant.
(Attn : Lt. Bongarzone).

1. Reference recent conversation Lt. Bongarzone and Major Wm. C. Ballance.

2. This Sub-Commission would be glad if you would kindly arrange for the printing of 250,000 Movement of Civilian passes (and duplicates) as per specimen submitted.

3. The passes (and duplicates) should be made up in pads of 50. The original pass should be yellow in colour and the duplicate white. The numbers of the passes should range from B. 000,001 upwards.

4. Each pad should have a top cover with the following instructions printed thereon in English:-

" Movement of Civilians' Passes

Notes for the Guidance of Officers
Completing Passes.

632

- (1) The use of blacklead pencils and facsimile signature stamps is forbidden.
- (2) Separate passes must be issued in respect of each person.
- (3) Applicants full name, address and identity card number must be shown, and passes must be signed by applicants before issue.

- 2 -

- (4) The validity of passes must not exceed the minimum time required by the holders to complete the journeys and transact their business.
 - (5) All amendments to passes must be made by way of endorsement on the back of the passes.
 - (6) Passes for travel to places forward of Security Control Line must be approved for issue by the SCAO/RC concerned in the zone.
 - (7) Passes for travel to places inside the Prohibited Frontier Zone may be issued at the point of departure by AMG/AC Officers.
 - (8) The issue of passes is a Public Safety responsibility."
5. The passes are urgently required.
