The attached blank form (No.7) of Italian War Correspondents' passes has been printed by this Branch in agreement with AFHQ PRO. The actual wording was set out by AFHQ.

Six of such passes have been issued so far, namely to:

No 2	Giuseppe SALA	Il Popolo
No 3	Mario SOLDATI	Avanti! and Unità
No 4	Gino DE SANCTIS	La Patria
No 5	Gino PINCHERLE	ANSA

The procedure for issuing these passes is as follows :

a) The Italian Undersecretariat for Press suggests to us the name of some suitable journalist to be appointed as a war correspondent.

b) This Branch contacts AFHQ PRO on the advisability of having such Correspondent accredited and copy of correspondence is sent up to Land Forces SC. If approved the journalist is given an AC journalist's card after screening by Security Division and other Italian authorities (Epuration, etc.).

c) As final step a War Correspondent's pass is then completed and forwarded for signature to AFHQ PRO and GSI (b) Allied Armies in Italy, together with 2 spare photos of the correspondent.
