SUBJECT : Issue of passports.

TO : Ministry of Interior.
(Direzione Generale della Pubblica Sicurezza).

1. Reference is made to your Polizia/IV/10.42346/19/1, dated 16 May, 1945.

2. This Headquarters is in agreement with the suggestion that all matters relating to the renewal and issue of passports is a matter entirely for the Italian Authorities.

3. It will be remembered of course that no person is authorized to leave Italy unless such person is in possession of a Military Travel Authorization, or equivalent document, issued by Allied Force Headquarters.

4. Applications for military travel authorizations have hitherto been dealt with by Officers attached to this Commission, but Allied Force Headquarters has now authorized Questori to deal with such applications.

5. A communication will be forwarded shortly with regard to the matters referred to, in preceding paragraph.
