TO : HQ AMG Naples Commune, Public Safety Division, Naples.

The firm Luigi PISCITELLI & Sons, contractors for bedding and equipment to the Carabinieri, have addressed to this HQ theletter enclosed herewith. The firm would like to buy barracks and equipment items which presently are being sold by the Allied Authorities.

The a/m firm at present is completely devoid of goods following the destructions and locting it suffered during the war, and following Allies requisitions and two big thefts. The firm, therefore, is unable to provide CC.RR. stations with what needed. The stations, because of the war, for the last two years have not received what is necessary to make Carabinieri's life less uncomfortable.

We therefore, beg you to take in consideration the possibility of selling to the firm the goods enumerated in the enclosed letter.

As it is known to your HQ because of was evenements our firm has suffered the destruction or looting of a great deal of its goods. Consequently many CC.RR. stations cannot be provided with bedding, blankets, underwear and so on. We point out also the fact that a great quantity of goods formerly in stock in our warehouses were requisitioned by the Allied Authorities and therefore, we are practically unable to provide Carabinieri stations of the provinces we look after with all what is needed by them.

There is a strong demand for woollen blankets which cannot be obtained on the market and such items are badly needed now that winter is approaching.

We have been told that the Allied Authorities are selling great quantities of barracks and equipment material existing in Naples, Leghorn and other localities and therefore we ask your H.Q. to contact the Allies so that they will sell to our firm all or part of the following items:-

Woollen blankets	
Shee ts	5000
Beds or small folding beds	10000
Pillow cases	2000
Mattress covers	10000
Tables	10000
Boiling and frying pans	5000
o pang pang	500

The firm would take care for moving the a/m items from any place they are located at present.
