Further reference to the correspondence conducted which deals with the subject of civilians arrested in Sicily on political or security grounds.

2.

The Fourth Review Board was held at Catania on 2nd and 3rd February 1944 when examinations of new cases and re-examinations of certain cases classified at the First, Second and Third Review Boards were conducted in respect of both the American and British Zones.

3.

Prior to the assembly of the Board, GOC M.Q. No. 1 District had received a directive from AFHQ to reclassify all A(a) cases into two groups, viz;

- (a) those internees considered 'unsafe' to leave in the custody of the Italian authorities and thus to be evacuated to North Africa, and
- (b) those internees considered 'amiable' for continued detention in Sicily.

Upon the completion of the ordinary business of the Board these particular classifications were made and the recommendations will form the subject of a separate report.
