SUBJECT: Questore for Frosinone Province.

TO : RPSO Region 4.

1. Reference is made to your letter R4/PS/4 dated 21st June, 1944.

2. At the request of SCAO Eighth Army, Comm. Capo SAGGESE Giacinto was, on 16th June, 1944 ordered to proceed at once from the Questore of Naples to Frosinone to take up the temporary appointment of Questore of Frosinone.

3. SAGGESE left Naples on 17th June, 44 and reported to the Provincial Commissioner AMO Frosinone. It has been learned that after a few days he was granted permission to return to Naples to fetch some personal belongings. Owing to transport difficulties SAGGESE did not leave Naples for Frosinone until 26th June 1944.

The position should now be satisfactory.

SUBJECT: Questore of Prosinone,
Inquiries on Giacinto SAGGESE, Questore of Naples.

TO : Security Branch, HQ, A.C.C.
(Attention: Maj. JOHN A. MC KAY)

1. Reference is made to Interior Sub-Commissioner's letter dated 5 June 1944, (Ref: ACC/A/1/35/INT.) and your indorsement thereon dated 7 June 1944.

2. The following information dated 10 June 1944 (Evaluation B-3) had been received:-

a. Dott. Giacinto SAGGESE was a Commissioner of the Pubblica Sicurezza (not Questore) at the Questura of Naples.

b. He was a member of the P.N.F. but, it is claimed, only to enable him to remain in service with the P.S. There are indications, however, that he was in touch with anti-Fascists, expressed anti-Fascist sentiments and attended anti-Fascist meetings. Immediately following the dissolution of the P.N.F., he made contact with several anti-Fascists in the Naples area.

c. He resides at Via S. Caterina da Siena No. 39, but originates from S. Angelo dei Lombardi. He is married to a school-teacher and is understood to own a certain amount of property.

d. It transpires that he is not "persona grata" with LAURICELLA who had him dismissed on the charge that he had failed to attend office in regulation uniform which was typically Fascist.

e. So far as has been ascertained, Dott. SAGGESE is professionally capable and there appears to be no doubt as to his moral integrity.
