(1) Telegraphic orders for the transfer of GIAMMORCARO Felice have been received from the Minister of Interior.

(2) This official was formerly Questore of the Province of Messina and was transferred to a position as Inspector of Western Sicily by AMG order. The High Commissioner has recently proposed to the Minister that this official be assigned as Questore of Catania, thus leaving vacant the post of Inspector of Western Sicily. It is understood that GIAMMORCARO is being assigned as Reggente Questore of the Province of Aquila which is difficult to understand because of his previous grade and assignment and his fine record since the occupation.

(3) The public safety problem in Sicily is delicate and the transfer of GIAMMORCARO Felice will further weaken the public security forces.

(4) It is requested that the matter be called to the attention of the Ministry.
