Promoted vice-questore in 1932, he remained in Salerno.

Promoted Questore in December 1941 he administered the Enna and Frosinone Questure.

He was discharged and put at disposition, by the Nazi-fascist government.

It is stated that there is no Questore for the Province of Pesaro - Urbino, and that the post is at present being filled by the Vice Questore, SALERNO Luigi. Although stated to be sound and reliable, Salerno is old and not considered suitable to fill the post permanently.

The Provincial Commissioner has asked if Vice Questore CIANCI, now believed to be at Campobasso, could be appointed to Pesaro, and recommends CIANCI for the post.

1. There is no questore for the Province of PESARO-URBINO. The post is being provisionally filled by the existing Vice-questore of the Province, SAVERIO Luigi. Although this official is a sound and reliable man, he is considered too old and lacks the necessary drive to fill the post permanently.
2. It is accordingly requested that a permanent official may be provided to fill the post of questore for PESARO-URBINO as soon as possible. In this connection the Provincial Commissioner would particularly like a Vice-questore named CIANCHI who was with him previously, to be made available for this post if possible. CIANCHI is believed to be Vice-questore at Campobasso at the moment, and is considered by the E.C. PESARO to be fit to hold the post of questore.
3. In the event of his not being available, however, another questore should be sent.
